Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Samir Dutta (55 yrs) S/O- Lt. Rasoli Dutta of Vill- Poradih PS-Puncha, District- Purulia with seizure of 15 (fifteen) bottle of Dil khush Country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (09.05.23) while I, SI Sujay Kundu, along with C/931 Laltu Pal and C/827 Rupchand Bauri both of Puncha PS were performing special mobile duty vide Puncha PS GDE No-343 Dt. 09.05.23 and acting on source information after consulting you at about 19.25 hrs reached at Poradih village and held raid in the open place back side of the Sunil line Hotel at Poradih village PS- Puncha, Dist- Purulia on Dhadki -Indpur pitch road. and found that the above noted person was keeping / selling liquor which were kept in his hand bag, in the open place which back side of the Sunil line Hotel at Poradih village on demand Samir Dutta failed to produce any valid documentary/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act 1909 so he was arrested on 09.05.23 at 20.05 hrs U/S 67 BE act and also 15 (fifteen) bottle of Dil khush Country spirit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled out of which 01 (One) bottle Dil khush collected as a sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo and handed a copy of the same to arrestee.

The arrested accused namely Samir Dutta (55 yrs) S/O- Lt. Rasoli Dutta of Vill-Poradih PS-Puncha, District-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Samir Dutta (55 yrs) S/O- Lt. Rasoli Dutta of Vill- Poradih PS-Puncha, District-Purulia under proper section of law.
