Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Amar Duary (34 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha , District- Purulia with seizure of 14 (fourteen) bottle of Dil Se Country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (09.05.23) while I, SI Sunil Kr, Banerjee, along with C/817 Biswajit Kundu and NVF/ 1043 Sazad Ansary both of Puncha PS were performing special mobile duty vide Puncha PS GDE No-346 Dt. 09.05.23 and acting on source information after consulting you at about 19.45 hrs reached at Tusugoria more and held raid in the shop of Amar Duary (34 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha , District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, at Tusugoria more on demand Amar Duary failed to produce any valid documentary/ authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act 1909 so he was arrested on 09.05.23 at 20.25 hrs U/S 67 BE act and also 14 (fourteen) bottle of Dil Se Country spirit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled out of which 01 (One) bottle Dil Se collected as a sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo and handed a copy of the same to arrestee.

The arrested accused namely Amar Duary (34 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha , District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Amar Duary (34 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha , District- Purulia under proper section of law.
