Respected Sir,

In producing herewith one accd. person namely Jiten Bauri (27yrs) S/O- Nanda Bauri of Vill- Baramesya PS-Puncha, District- Purulia with seizure of 21 Ltr ID Liquor which were seized under proper seizure list.

I beg to submit that today (30/05/2023) at 17:55 hrs while myself along with C/817 Biswajit Kundu & C/887 Amit Bauri vide Puncha PS CC No - 1441/2023 Date 30/05/2023 were performing anticrime mobile duty at Baramesya Village side under Puncha PS .During mobile duty received source information that one Jiten Bauri (27yrs) S/O- Nanda Bauri Barmesya PS-Puncha, District- Purulia has illegally stocked ID liquor in house at Baramesya village under PS- Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Baramesya Village to work out the information. At 18:05 hrs after reaching at Baramesya village held raid in a house of Jiten Bauri (27yrs) S/O- Nanda Bauri of Vill- Baramesya PS-Puncha, District- Purulia and found that the above noted person was keeping / selling ID liquor which were kept in his house, on demand Jiten Bauri failed to produce any valid documentary authority in respect of selling of ID liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also seized 21 Ltr ID liquor in 2 plastic container which were seized under proper seizure list duly signed by witnesses and labeled and one Ltr taken is taken as sample in a plastic bottle which is sealed and labeled. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list U/s-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

The arrested accd. Jiten Bauri (27yrs) S/O- Nanda Bauri of Vill- Barmesya PS-Puncha, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of ID liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested Jiten Bauri (27yrs) S/O- Nanda Bauri of Vill- Barmesya PS-Puncha, District- Purulia under proper section of law.
