Sub: Prayer for lodging FIR under proper section of law.

Respected Sir,

In producing herewith the seized vehicle (Tractor) having Reg. No. WB 55A 8010 attached with Trolley having no number plate loaded with sand approx 100 cft. with a proper Seizure list.

The fact brief is that on 08.05.2023 at 17.15 hrs I along with force 1) C/- 692 Ukil Ch. Mahato, C/- 1137 Sridam Bauri & NVF- 187 Upinath Tudu all of Purulia (M) PS left the PS for night mobile duty vide Purulia (M) PS C.C No- 1501/2023 and GDE No- 374 Dtd. 08.05.2023 at Ranchi road area. During my night mobile duty, today (09.05.2023) at 06.25 hrs I received information that a suspicious tractor loaded with sand was coming from Kantabera Ghat (Kasai River). Accordingly, I informed the matter to I.C Purulia (M) PS and as per his direction, I along with force proceeded towards that place to work out the information. While I, along with the force, arrived at Sindri village and found 01 (one) tractor attached with a trolley loaded with sand standing near the house of Ramesh Mahato of said village. I along with the force intercepted the vehicle (Tractor) having Reg. No- WB 55A 8010 attached with Trolley (No number plate) loaded with Sand approx 100 Cft without driver or any other person at 07.05 hrs and I found the vehicle as well as goods identical as I received prior information. I moved through the surrounding area to trace out the said driver or owner of said detained tractor but nobody was found to stand its ownership. During primary enquiry it was found that the owner and driver of the said vehicle loaded said sand by illegal means for selling the same to make their own profit by dishonestly and they have been running a clandestine business. It is reasoned to believe that driver in cahoots with the owner of the vehicle and others procured the said sand from Kansai River under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business.

So I seized the (tractor) having Reg. No- WB 55A 8010 attached with Trolley (No number plate) loaded with Sand 100 Cft. (approx) under proper seizure list. The seizure was made in between 07.15 hrs and 07.25 hrs in presence of available witnesses duly signed by them. Thereafter, I brought the said seized tractor to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances I therefore, pray before you that kindly take lawful action against the owner and driver of seized vehicle (Tractor) having Reg. No- WB 55A 8010 attached with Trolley (No number plate) loaded with Sand under proper section of Law.
