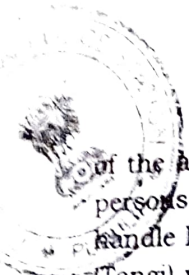

Sir,

In producing here with arrested accused persons namely (i) Jagannath Karmakar (26) S/o Lt. Sadananda Karmakar of Vill- Bongabari (ii) Shyamal Karmakar (19) S/o- Bhajohari Karmakar of Vill- Bongabari, both of PS- Purulia(M), Dist- Purulia and seized articles (1) one iron made chopper with iron handle length approx 1.6 inch, (2) one iron rod, Length approx. 3 ft, (3) One Tabla (Tangi) with wooden butt approx 4 ft. in length & (4) one sword length approx 2.5 Fit (5) One caravan rope red colour approx 3.1 inch lodged complain against them and 08/09 others to the effect that on 21.05.2023 at about 22:35 hrs received a credible tip that a gang of dacoits being armed with deadly weapons like fire arms assembled in an open deserted place near the entrance of Charrah Solar Power plant at under Purulia (M) PS, Dist- Purulia and they were preparing themselves for committing dacoity at Golkunda village side. This matter was informed to I.C Purulia (M) PS subsequently and noted the information down to the GDE Vide Purulia (M) PS GDE No 1103, Dtd. 21.05.2023. On getting the tip off as per your kind order myself accompanied with ASI Ajoy Mukhopadhyay and force namely (i) C/- 2505 Anup Kundu (ii) C/- 982 Shyamal Rajowar (iii) C/- 06 Debdas Mukherjee & (iv) C/- 1137 Sridam Bauri all of Purulia (M) PS vide CC No. 1628/2023, dated 21.05.2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near the entrance of Charrah Solar Power plant at 23.45 hrs leaving the Police vehicle No- WB 56C 5423 and started to proceed for the anticipated place on foot. At 23.55 hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 11/12 persons assembled in the open land in the dark side of a tree and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to detain in rounding up only 02 (Two) of them at 00.15 Hrs dated 22.05.2023 while the rest 08/09 managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered one iron made chopper with iron handle length approx 1.6 inch from the back side waist of Jagannath Karmakar (26) S/o- Lt. Sadananda Karmakar of Vill- Bongabari, PS- Purulia(M), Dist- Purulia and one Tabla (Tangi) with wooden butt approx 4 fit in length from the left side waist of accused Shyamal Karmakar (19) S/o- Bhajohari Karmakar of Vill- Bongabari, PS- Purulia (M), Dist- Purulia and also searched the place of assembly with torch light and recovered one iron rod, Length approx. 3 ft, & one sword length approx 2.5 Fit & One caravan rope red colour approx 3.1 inch. Then in between 00.25 hrs to 00.55 hrs on 22.05.2023 from the place of assembly



of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) one iron made chopper with iron handle length approx 1.6 inch, (2) one iron rod, Length approx. 3 ft, (3) One Tabla (Tangi) with wooden butt approx 4 fit in length & (4) one sword length approx 2.5 Fit (5) One caravan rope red colour approx 3.1 inch from the place of assembly under proper seizure list as well as labeled duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there with 08/09 others for committing house Dacoity at Golkunda Village side, in which (1) Sk Masim Chalak @ Karaj of Vill- Hutmura, PS- Purulia(M), Dist- Purulia, (2) Sk. Salimul (27) S/o- Sk. Guffar of Hutmura Daripara, PS- Purulia (M), Dist- Purulia, West Bengal (3) Rajesh Karmakar S/o- Sudhir karmakar of Vil- Belma, PS- Purulia (M), Dist- Purulia, (4) Sk. Sain @ Saina S/o- Lt. Sk. Jamir of Vil- Hutmura, PS- Purulia(M), Dist- Purulia also with them and managed to escape from the spot. I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because it was dead hour of night and it was a lonely place and I got information that they assembled and making preparation for committing Dacoity on gun point which might endanger of life of Public witnesses, after the arrest and kept the gun in safe position. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house Dacoity. So, after observing all formalities I arrested those preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Jagannath Karmakar (26) s/o Lt. Sadananda Karmakar of Vill- Bongabari, PS- Purulia (M), Dist- Purulia & (2) Shyamal Karmakar (19) S/o- Bhajohari Karmakar of Vill- Bongabari, PS- Purulia (M), Dist- Purulia and seized articles along with 08/09 others under proper section of law.
