This is to inform you that I Santosh Kumar Jain, S/O Sagar Mall Jain of Taxi Stand Purulia, PS – Purulia Town, Dist – Purulia, West Bengal, 72301 being a secretary of Purulia Digambar Jain Mandir which is situated at Vill – Anaijambad (Mahadev Bera), PS – Purulia (Muffasil), Dist- Purulia and which is exclusively situated within the Jurisdiction of your PS that on 25/05/2023 at night one unwanted Incident occurred in your said temple because some part of Jain Murti of Lord Adinath was stolen by some unknown Miscreants and they also broke another Lord Chanda Prabhu statue and also stole the Dan Peti of the said temple.

Today Morning (26/05/2023) at about 4:00 AM our caretaker namely Manojit Babu informed the matter to our Jain Committee, Purulia accordingly when we come to know the incident we rushed to the said temple and saw three locks are broken and theft the above mentioned statues and the Dan Peti (Approx Amount: 12,000/-).

So I appeal before you to take Necessary steps for recovery of those statues which is exclusively rarest and the price is beyond imagination and the said Statue of Lord Adinath is also the emotion of entire Jain Samaj.
