Respected Sir,

In producing here with 02(two) accused persons namely (1) Ganesh Mahato (40), s/o-Lakhiram Mahato of Vill-Kashijhoria, PS-Pindrajora, Dist-Bokaro, Jharkhand (2) Kartik Mahato (27), s/o-Nibaran Mahato of Vill-Jamra (Sidhi) ,PS-Joypur, Dist-Purulia, along with 01 (One) seized vehicle having registration Nos WB67B 7101 loaded with approx 11 TN coal seems to be steam coal and also taken sample of 02 kg coal from the truck to the effect that I ASI Asish Adhikary along with C/241-Sumit Chakraborty, C/3150 Subodh Kr. Bauri both of Purulia(M)PS, Dist-Purulia. On 27.05.2023 at about 17.05 hrs. from my source, I inform that from Jharkhand towards Barakar road illegal transportation happened. After receiving the information I contacted with my I.C and as per his guidance and instruction I along with force vide Purulia(M) Spl. CC No-1688/23 Dtd-27.05.2023 and PS GDE No-1382 Dtd-27.05.2023 at about 18.05 hrs left for PS to track and stopped this illegal transportation. After that I managed to stop one vehicle near Nadiara village more on 27.05.2023 at about 20.30 hrs. on seeing the Police party 01/02 persons were tried to flee away but somehow we managed to apprehend the above noted persons. On asked they failed to produce any valid documents in respect of loaded coal. On preliminary enquiry it could be learnt that they were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly I seized the above noted vehicles loaded with coal under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list and during seizure I had taken 02 Kg coal from the truck as sample. After that I arrested them after observing all formalities regarding arrest. After that we made proper arrangement and brought the vehicles loaded with coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested persons, driver and helper of the one (01) seized vehicle, owner of the one vehicle and other associates under proper section of law.
