Sir,

With due respect I, the undersigned, Hostel Super of the Ashram Hostel (ST Girls) of the above named school would like to inform you and appeal before you for taking necessary steps regarding the following matters:-

1. That the Head Master has been expelled me with the help of two Assistant teacher namely 1. Prasanta Sinha Mahapatra 2. Sisir Kumar Mandal from the Ashram Hostel (ST Girls) of the school on 09/12/2021 forcefully because I am belonging in a down trodden backward based community i.e. S.T. (Santal) Community.
2. That the Head master along with two teachers (Prasanta Sinha Mahapatra and Sisir Kumar Mandal) jointly have been denied to reengage me in the Ashram Hostel of the School as hostel super though a settlement of my reengagement along with other hostel staff has been finalized in your Police station on 13/09/2022 on the basis of complaint by the president of the school. Because my category is in ST Community.
3. That the due payment for the period from April 2021 to till date (April 2023) has been held up by the Head master intentionally where in the State Govt. has already been placed my salary @ 8000/- per month without any breaking/continuously in the school's Bank A/c No. 0710010291200 but why he would not pay to me? I don't know. Above all, I have already been submitted prayer for solution of the aforesaid Matter to the concerned authorities again and again like the DM Purulia, Adm (dev) Purulia, P.O. cum DWO, BCW Dept. Purulia, DI (SE) Purulia, BDO Purulia- II, but failed. Hence under the above circumstances, According to the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 in India you are requested to take an arrangement in this regard as early as possible. So that I can get a relief / protection from such type of ill-treatment and harassments as per above Rule. Waiting your early action.
