## Respected Sir,

In producing herewith the seized vehicle (Tractor) having (i) Reg. No. WB 56U 4731 (ii) Chassis No. MBNTFAEDBNRM00292, Eng. No. RNM7EBN0290 attached with Trolley having no number plate loaded with sand approx 100 cft. with a proper Seizure list.

The fact brief is that on 27.05.2023 at 17.05 hrs I along with force 1) C/- 321 Tulsidas Roy, C/-982 Shyamal Rajwar both of Purulia (M) PS left the PS for day mobile duty vide Purulia (M) PS C.C No- 1682/2023 and GDE No- 1350 Dtd. 27.05.2023 at Purulia to Jharkhand border area. During my day mobile duty, today (27.05.2023) at 16.15 hrs I received a secret information that two suspicious tractor loaded with sand is coming from Bhul Ghat (Kasai River). Accordingly, I informed the matter to I.C Purulia (M) PS and as per his direction, I along with force proceeded towards that place to work out the information. While I, along with the force, arrived at in between Kultard to Nadiara village and found 02 (Two) tractors attached with a trolley loaded. I along with the force intercepted the vehicle (Tractor) having (i) Reg. No. WB 56U 4731 (ii) Chassis No. MBNTFAEDBNRM00292, Eng. No. RNM7EBN0290 attached with Trolley (No number plate) loaded with Sand approx 100 Cft without driver or any other person at 17.15 hrs and I found the vehicle as well as goods identical as I received prior information. I moved through the surrounding area to trace out the said drivers or owners of said detained tractor but nobody was found to stand its ownership. During primary enquiry it was found that the owners and drivers of the said vehicles loaded said sand by illegal means for selling the same to make their own profit by dishonestly and they have been running a clandestine business. It is reasoned to believe that drivers in cahoots with the owners of the vehicle and others procured the said sand from Kansai River under Purulia (M) PS side by any means for transporting the same to run this clandestine business.

So, I have seized the (tractor) having (i) Reg. No. WB 56U 4731 (ii) Chassis No. MBNTFAEDBNRM00292, Eng. No.-RNM7EBN0290 attached with Trolley (No number plate) loaded with Sand 100 Cft. (approx) under proper seizure list. The seizure was made in between 17.15 hrs and 17.30 hrs and 17.35 to 17.50 in presence of available witnesses. Thereafter, I brought the said seized tractor to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances I therefore, pray before you that kindly take lawful action against the owner and driver of seized vehicle (Tractor) having (i) Reg.
