
An Application on behalf of the Petitioner/Complainant,

Most respectfully sheweth:-

- That the accused no.1 happens to be the daughter-in-law of your petitioner/complainant.
- 2) That on 15/02/2015 a valid Islamic marriage was solemnised between the son of your petitioner/complainant and the accused no.1 & the marriage still subsists. The accused no.1 was welcomed in her marital home with religious fervor and great happiness. The son of the complainant/petitioner had lot of sweet conjugal dreams in their marital voyage. Since marriage, their married life was peaceful for few years. Thereafter the demands of the accused no.1 gradually increased day by day and the son of your petitioner/complainant also tried to fulfill her daily needs as per his financial status, but sudden outbreak of COVID-19 followed by the Lockdown due to the said pandemic the son of your petitioner started suffering from financial stringency. Despite such facts the the son of your pressurize accused person no.1 continued to petitioner/complainant to continue spending considerable amount for her luxurious life. But the accused no.1 did not want to understand financial trouble for the Lockdown and used to pick up quarrel and disturbance even on very flimsy pleas & pretexts and also used to go frequently to her father's house on her own volition and without the consent of her other inmates even leaving her minor wards when the son of your petitioner used to disclose his inability.


After that the son of your petitioner/complainant went outside to work as a day labour in the hope of some extra income. However the son of





your petitioner/complainant started sending money for the daily expenses of the accused no.1 as per his capacity but such amount could not make the accused no.1 and she started claiming more & more money for her modern lifestyle, even in physical absence of her husband the accused no.1 started putting your petitioner under pressure with all her exorbitant claims.

- 3) That on 13/02/2023 at about 8 A.M. the accused no.1 told your complainant/petitioner that she would go to the market and demanded money from her. As your petitioner/complainant could not give it to the accused no.1, the accused no.1 called the accused no.2 & prior passing of any opinion or sharing the situation to him the accused no.2 dashed your petitioner forcefully resultantly she failed down on the earth. Then the accused no.1 with the intention of killing your petitioner/complainant picked up the hailstone and tried to hit your petitioner/complainant on her head, then your petitioner/complainant then your petitioner when raised her hand to prevent her head from such brutal attack, it hit the left hand of your petitioner/complainant and she received grievous injury. After that your petitioner/complainant started groaning and raised hue & cry to save herself, when the neighbouring people gathered, the accused no.1 & the accused no. 2 the neighbors Then from the spot. away petitioner/complainant took her to Deben Mahato Government Medical College & Hospital, Hatuara where the attending medical officer opined that the left hand of your petitioner/complainant was broken & as per the advice of the attending medical officer x-ray was done and the opinion of the doctor became true. Later on the said hand of your petitioner/complainant was repaired with plaster.
- 4) That your petitioner/complainant had been to Purulia (T) with a letter of complaint depicting inter-alia all the real scenario what happened wrongfully upon her but the officer on duty asked her to come on the next week with a plea of their busyness with law and order duty, but when your petitioner /complainant again had been there after seven days the officer on duty not only refushed to accept the letter of complaint, he also did not extend permission to your petitioner/complainant to meet the I/C of the concerned P.S.
- 5) That your petitioner/complainant then sent her letter of complaint under registered cover with A/D on 15/03/2023 addressing the I/C Purulia (T) P.S. but then too no step was taken towards institution of any specific case so that the accused persons be prosecuted and punished.

- 6) That due to such inaction on the part of the police personnel of the concerned P.S. your petitioner/complainant informed the matter in writing to S.P Purulia on 27/03/2023, but unfortunately the District Police Administration still turned deaf ears to the same and no specific case has yet been instituted.
- 7) That search and seizure is very much warranted in the instant case and your petitioner/complainant is a very poor and rustic woman heaving no such annual income for incurring expenses of a complaint case.



In light of the above it is therefore prayed that Your Honour may graciously be pleased to forward the instant petition of complaint to the Inspector-in-charge of Purulia (T) P.S. with a direction upon him to investigate into the case treating the same as F.I.R under the provisions contemplated under sections 156 (3) Cr.P Code.
