


watchman and care taker at Sri Sri Chandimata Mandir ,Boro under Peety's Shebaaitship which is largely known to the public of the locality.

2. That Accd. persons are the provigens of the local area and all time try to do mischief with the property of " Sri Sri Chandimata Mandir" with their hing handed action and muscle power accordingly on the day of incident at relevant point of time hatching a conspiray to fulfill their oblique intention entered into the Mandir premises and stated uttering abusive language towards the complt and his associates in which complainant raised voice whereupon i Accd persons grew furious and jointly attacket the complainant & witness No.1 with fist & blows and also up pulled the complt and witness No.1 daught hold their neck fummeriling the peaceful possession of the " Mandir premises ".

3. That hearing sireanng number of persons gathered there and intervened into the matter whereupon Accd the P.O. by giving out threat " Unless all the previous complaint filed against them (Accd. persons) are withdrawn by the cobatt they will go long with such activities) Need less to say Accd. person also gave out threat to eliminate the lives of the complainant and his associate in a convenient situation .

4. That complainant reported the matter in writing with Raghunathpur P.S. on 01-04-23 vide GDE No. 37/23 but no action has yet been taken against the culprits . Thereafter complainant sent his grievance to the S.P. Purulia on 4.4.23 through Regd. post byt ucilded nothing.

5. That finding no other alternatives taking as the last recourse complainant seeks hid relief before Ld.court for the
