2. That the complainant has executed a power of attorney in favour of his lawful attorney, father Radhamadhab Dittababu and entrusting him to do lawfully everything in C/W the tractor specifically mentioned in the power of attorney.
3. That accd. person is known to the complainant and his family member.
4. That due to some unavoidable circumstances complainant felt necessary to sellout the said tractor in which accd. person agreed to purchase the said with its highest bid of Rs:- 4,25,000/- only. Be it noted an agreement was also executed in between complaint. and accd. person on 03-12-2019 even an amount of Rs:- 30,000/- out of total consideration amount and it was settled in the said agreement accd. will repay rest amount monthly installment basis direct to the financier of complt. i.e. Sriram Finance company Ltd.
5. That accd. person took custody of the said tractor from the complainant and started using the vehicle for his own purpose upto 22-01-2023.
6. That needless to say complt. had every belief/belief(s) that the accd. person was rightly paying the installment amount to the financier of complt. but on information from the financier complt. came to be know that the accd. person intentionally did not continue the payment of installment, as a result a huge fiscal burden saddled upon the complainant owing to such negligent on the part of the accd. person.
7. That the complt. made several communication with the accd. person but avoid the same on several pretext and also got-up story showing his innocence before the complt. Be it noted

during his custody of the tractor he used the same randomly without its proper maintenance.

8. That financier of the complt. further sent reminder for making payment of the borrowing amount wherefrom complt. realised that accd. intentionally had not paid the stipulated amount of Rs:-4,55,000/-

9. That accordingly seeing such overt act of the accd. person complt. demanded his tractor from the accd. person in which initially accd. refused to do the same but ultimately from the on 22-01-2023 complt. took possession of the tractor from the accd. person in a wretched condition with the intervention of local post at chelyama.

10. That during the episode accd. person also gave threat to takeaway the said tractor from the possession of the complt. on any opportunate moment. Even in exchange of any means. That complt. verbally informed the matter to the local P.S. and initially made endeavour and more then a month elapsed.

11. That from the foregoing paras it is crystal clear that accd. person has committed a serious breach of trust of the complt. and besides that accd. person has also cheated the complt. in the aforesaid manner.

12. That complt. informed the matter to the I/C Raghunathpur for his remedy against the accd. person in writing in which P.S. concern assured the matter to be looked into, but even after lapse of week no fruitfull result came accordingly complainant informed the matter to the S/P Purulia through Regd. post on 11-04-23 but till date nothing yielded, hence finding no other alternative complt. seeks his remedy before the Ld. court.
