In producing herewith arrested 02 (Two) accused persons namely (1) Puna @ Chhutu Bauri (32), s/o- Lt Moriram Bauri of Cinematola and (2) Pradip Gorain (25) S/o- Sanjoy Gorain of Kanki Basti both of PS- Santaldih, Dist. -Purulia along with original seizure list and seized articles i.e (1) One Iron Rod with bamboo handle total length approx 02 feet 06 Inch, Iron side length approx 01 feet 03 Inch and Bamboo Side (handle) length approx 01 feet 03 Inch from the possession of Puna @ Chhutu Bauri, (2) One Iron made Cuttery total length 01 feet 2.5 Inch with handle, Iron side length 9-1/2 Inch, wooden side (handle) length 05 Inch from the possession of Pradip Gorain.

I beg to report that on 26.05.2023 at 21:05 hrs received an information from secret source that some miscreants had assembled in a dark place at Football ground near Chakbad High School under Santaldih PS with deadly weapons with a intend to commit dacoity any house/shop under Santaldih PS jurisdiction and they were preparing themselves for the said purpose. Accordingly, the matter was diarized in Santaldih IC (BCW) GDE No. 549, dated - 26.05.2023 and the matter was informed to IC, Santaldih PS. As per order of IC, Santaldih PS, I, SI Shuvankar Sarkar along with C/29 -Koushik Ghatak, C/1183 Subhas Kundu and NVF/593 Thakurdas Soren all of Santaldih IC (BCW), left the PS to workout the information of secret source as noted above vide Santaldih IC (BCW) CC No. 980, dated - 26.05.2023 and Santaldih IC (BCW) GDE No. 550, dated - 26.05.2023 by Govt. vehicle. At about 21:35 hrs we arrived at Football ground near Chakbad High School I and parked the Govt. Vehicle in a hide them in secret place and I briefed all forces properly, guarded and cordon the area and approached towards the back side of the football ground. After sometimes we watched that some persons were whispering among themselves. On seeing Police Party they started to flee away. After a hot chase we apprehended above noted two accused persons when 3/4 others managed to escape away. On being asked the above noted accused persons disclosed their identity as stated above. On interrogation they did not give any satisfactory answer about their present there in the mid-night. They also made different statement about their presence at Football ground near Chakbad High School in different times. On search (1) One Iron Rod with bamboo handle total length approx 02 feet 06 Inch, Iron side length approx 01 feet 03 Inch and Bamboo Side (handle) length approx 01 feet 03 Inch from the possession of Puna @ Chhutu Bauri, (2) One Iron made Cuttery total length 01 feet 2.5 Inch with handle, Iron side length 9-1/2 Inch, wooden side (handle) length 05 Inch from the possession of Pradip Gorain. They did not give any satisfactory reply about the above articles which were in their respective exclusive possession.

After prolonged interrogation they confessed that they had assembled there to prepare and commit Dacoity at the house of Suresh Mahato at village Chakbad under Santaldih PS. Accordingly, I Seized those above noted articles after preparing proper seizure list duly signed by the witnesses from 02 (two) alleged persons at 22:15 hrs to 22:35 hrs. The above noted accused persons have been arrested on 26.05.2023 at 22:45 hrs to 22:55 hrs after maintaining all formalities and informing them the ground of arrest. Before their search we requested them to search the Police team and they also searched us and found nothing except uniform and other govt. properties.

Hence, I, pray before you that a specific case may kindly be started as per law against the 02 (two) accused persons (1) Puna @ Chhutu Bauri (32), s/o- Lt Moriram Bauri of Cinematola and (2) Pradip Gorain (25) S/o- Sanjoy Gorain of Kanki Basti both of PS- Santaldih, Dist. - Purulia and 3/4 others and arrange for its investigation.
