Sir,

In producing here with arrested 01 (one) accused person namely Pintu Saw (36 yrs) S/O Shiv Kumar Saw of Tata Colony, Parasia, PS- Jorapukur, Dist Dhanbad, Jharkhand and seized articles (1) One white colour Hyundai car bearing Registration No. JH-10P/0033 having Engine No. D4FA7U307052, Chassis No. MALCN41VR7M03073 (2) one iron made "BHOJALI" length approx 20 inch, (3) One Iron rod length approx 2.5 feet & Diameter 1.5 inch and (4) One knife having plastic butt length approx 15 inch, (5) One steel LED Torch light in which Eveready is written on the body with 03 pcs Eveready battery, (6) One nylon rope, do here by lodged complaint against arrested accused and 05/06 others to the effect that on 06.05.23 night at 22:15 hrs received a credible source information that a gang of dacoits being armed with deadly weapons reached with a white colour car at near Krishnapur bazar area and assembled there for preparing themselves to commit dacoity at Krishnapur bazar area. The matter was diarized by duty officer SI Bikash Ch Patra vide Santuri PS GDE No.228 Date-06.05.23 and as per order of O/C Santuri PS myself along with SI Mrinmay Bhakta, ASI Madhu Mangal Bauri, C/-1452 Sadhan Ch Kar, C/ 1336 Madhusudhan Paramanik, NVF/131 Jahan Murmu, HG/1789 Thakurdas Bauri all of Santuri PS vide CC No.1521/23 date 06.05.23 left PS to work out the information. We reached near Krishnapur bazar at 22.45 hrs leaving the Police vehicle at a distance and proceeded for the anticipated place on foot. At 22:55 hrs we reached at anticipated place, led on ambush being led by the source and in the moon light we noticed that 06/07 persons were assembled near Krishnapur bazar in a dark and those persons are whispering from which it is clear that they are preparing themselves to commit dacoity at nearby house of Krishnapur Bazar area as it could be audible from the talks of the assembled criminals. We watched them and cordoned them. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away in the dark of night. We chased them and after a hot chase we succeeded in rounding up only 01 (one) of them while the rest 05/06 persons were able to escape. On asked he disclosed his identity as Pintu Kumar Shaw as noted above. I searched the above noted apprehended person and recovered one iron made "BHOJALI" length approx 20 inch from the exclusive possession of the above noted apprehended person and rest articles noted above recovered under the seat of driver of the car. After observing all formalities I seized the same under proper seizure list as well as label duly signed by apprehended person and witnesses as Alamat property. I also seized the above noted car which was used by the accused persons to commit the crime. On interrogation he confessed his guilt and he stated that he and 05/06 others have assembled there for committing house docoity. He also recollect the name of two coaccused persons as Promod Kumar (40 yrs) of Jharia Chilan Park, PS Jharia, Dist Dhanbad and Samser Khan (45 yrs) of Upar Kuli, PS Jharia, Dist Dhabnbad but he cannot recollect the names of other associates. I am to note here that I have to conducted search & seizure in

presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity which may be endanger of life of Public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended person and coassociates were assembled there for committing dacoity at Krishnapur bazar area under Santuri PS. So, after observing all formalities I arrested him preparing arrest memo and ground of arrest duly communicated to him.

Therefore, I pray that a specific case may kindly be registered against the arrested accused person namely (1) Pintu Saw (36 yrs) S/O Shiv Kumar Shaw of Tata Colony, Parasia, PS-Jorapukur, Dist - Dhanbad, Jharkhand, (2) Promod Kumar (40 yrs) of Jharia Chilan Park, PS - Jharia, Dist - Dhanbad, (3) Samser Khan (45 yrs) of Upar Kuli, PS - Jharia, Dist -Dhabnbad along with 03/04 unknown others under proper section of law and arrange its investigation.
