**Respected Sir,**

In producing here with the arrested accused person namely Haradhan @ Haru Bauri (45 yrs) s/o Lt. Nakul Bauri of Vill- Talberia, P.S- Santuri, Dist- Purulia along with the seized articles i.e 20 bottles of country spirit each bottle contains 600 ml, value of Rs- 55 X 20= 1100/- .

I beg to submit that today (29.05.2023), I along with force while performing evening mobile duty at about 17:45 hrs received a credible source information that one person namely Haradhan @ Haru Bauri (45 yrs) s/o Lt. Nakul Bauri of Vill- Talberia, P.S- Santuri, Dist- Purulia was selling Country Spirit (DIL SE) without any valid license from his house at Vill- Talberia, P.S - Santuri, Dist - Purulia. Accordingly, I along with force reached at the house of Haradhan @ Haru Bauri at about 18:25 hrs at Talberia village to work out the information and held raid there. During raid seeing the Police party some persons fled away. I searched the place with the help of accompanying force and found that the said person possessed and was selling Country Spirit bottles. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Hence he has committed offence U/S- 46A(C) B.E. Act 1909. Finding no other alternative I seized 20 (Twenty) bottles of country spirit styled as 'DIL SE' each bottle contains 600 ml and amounting Rs-55/- (Fifty five) each bottle, Total amounting Rs- 1100/-, under proper seizure list duly signed by the witnesses and labeled it. Out of which one bottle kept as sample. Then, I arrested the accused after observing all legal formalities.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Haradhan @ Haru Bauri (45 yrs) s/o Lt. Nakul Bauri of Vill- Talberia, P.S- Santuri, Dist- Purulia and arrange for its investigation.
