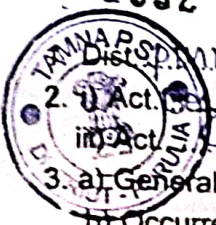

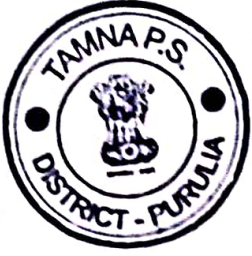

Respected Sir,

I, Gnan Sankar Pati S/o- Ramani Ranjan Pati of Vill+P.O- Chaka, PS- Khatra, Dist- Bankura, ASI of Police, of Tamna PS, Dist- Purulia producing herewith one arrested accused person namely Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). One white colour plastic jericin containing approx 09 Ltrs. of ID Liquor, 2) 07 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (28.05.2023) during my PS area mobile duty acting of a secret source information that one person selling I.D Liquor at Durku morh under Tamna PS, Dist-Purulia, so I along with i) NVF/1095 Tanuram Mahato & ii) HG/1698 Haradhan Kumar both of Tamna PS came to the spot at about 17:05 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend one person. On being asked he disclosed his identity as Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist- Purulia and he is selling ID liquor in his "Pan Shop" at Durku morh, PS-Tamna, Dist-Purulia. On demand he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jericin containing approx 09 Ltrs. of ID Liquor, 2) 07 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Hrishikesh Mahato (40 yrs) S/O- Lt. Krishnapada Mahato of Vill- Tamna, P.S- Tamna, Dist- Purulia as per proper section of law.
