Sub: To lodge FIR against owner and driver of tractor namely Dwaipayan Majhi (28 yrs) S/O Lt Bholanath Majhi of vill-Upar Jambad, P.O-Aharrah, PS-Arsha, Dist-Purulia of one red colour Mahindra B275 DI tractor having Reg. No. WB55B/3270, engine no-RLL2EAN0315 & chassis no-MBNABAEXKLRL01992 along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, 01(one) red colour Mahindra B275 DI tractor having Reg. No. WB55B/3270, engine no-RLL2EAN0315 & chassis no-MBNABAEXKLRL01992 along with trolley loaded with sand (approx 60 CFT). Today on 02.06.23 at about 08.05 hrs. acting on source information as per direction of OC Arsha PS, I ASI Tapan Kr. Mahata of Arsha PS along with (i) C/-146 Maheswar Sing Sardar of Arsha PS and (ii) C/300 Binoy Mahato SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for Bandu River Ghat, Hensla vide C.C No. 1391 Dtd. 02.06.2023. After we reached at Hensla Ghat, under Arsha PS at 08.45 hrs, we conducted raid on the Bank of Bandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Hensla Ghat on the Bank of Bandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party the driver namely Dwaipayan Majhi (28 yrs) S/O Lt Bholanath Majhi of vill- Upar jambad, P.O Aharrah, PS- Arsha, Dist- Purulia of said tractor tried to flee away, but we apprehended him. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Dwaipayan Majhi (28 yrs) S/O Lt Bholanath Majhi of vill-Upar Jambad, P.O-Aharrah, PS-Arsha, Dist-Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the, Owner of tractor bearing registration no- WB55B/3270 and driver Dwaipayan Majhi (28 yrs) S/O Lt Bholanath Majhi of vill- Upar Jambad, P.O-Aharrah, PS-Arsha, Dist-Purulia of above noted tractor along with the trolley for investigation.
