## The Officer in-charge Arsha PS, Purulia

Sub: To lodge FIR against owner and driver of one Powertrac EURO 439 without Reg. No. having Engine No. E3557188, Chassis No. T053495022EJ along with trolley (sand approx 60 CFT).

Sir,

In producing herewith, 01 (one) Powertrac EURO 439 without Reg. No. having Engine No. E3557188, Chassis No. T053495022EJ along with trolley (loaded with sand approx 60 CFT). Today on 03.06.23 at about 18.05 hrs. during evening mobile duty acting on source information and as per direction of O/C, Arsha P.S, I ASI Janardan Kumar of Arsha PS along with (i) C/-1140 Dayamay Mahato of Arsha P.S and (ii) C/333 Sitaram Mahato of SAP 7th BN camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 1404/23 & GDE No. 108 Dtd. 03.06.2023. After we reached at Rangamati sand ghat, under Arsha PS at 18.25 hrs, we conducted raid on the Bank of Rangamati Ghat on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Rangamati Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Rangamati Ghat, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
