Sir,

In producing here with one arrested accused person Shibu Sahis (54 yrs) S/O Lt. Monbodh Sahis of vill- Teyashi , P.S.-Arsha, Dist-Purulia along with following seized articles.

- 1) One white colour plastic container containing approx 12 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Janardan Kumar of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 18.06.22 at about 17.45 hrs. during my evening mobile duty at Arsha PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Teyashi village. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction, I along with C/- 15 Sushanta Kr. Dey of Arsha PS and C/- 353 Rahul Gorain of SAP 7th BN Camp at Arsha PS work out the information vide Arsha PS C.C. No. 1522/23 & GDE No. 801 dtd. 18.06.23. Reaching at Teyashi village at about 18.05 hrs we fixed-up in the house of Shibu Sahis (54 yrs) S/O Lt. Monbodh Sahis of vill- Teyashi, P.S.-Arsha, Dist-Purulia and found that selling of I.D Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehend the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized one white colour plastic container containing approx 12 ltrs. of ID liquor under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Shibu Sahis (54 yrs) S/O Lt. Monbodh Sahis of vill- Teyashi , P.S.-Arsha, Dist-Purulia under proper section of law.
