In producing here with the arrested accused persons 1. Dinesh Sahis (22 yrs) S/O Sudhir Sahis and 2. Bajrangi Munda (21 yrs) S/O Lt. Mangal Muda both of BCCL Colony, Dhowra Goshala OP. under PS- Sindri, Dist- Dhanbad, Jharkhand along with one truck having No. NL02N/9414 loaded with approx 119 pes of pipe branded as V-DCUPIPE, ESL Steel Limited and as each pipe OPC DN100, QAD-OK-K7 5.5 is engraved & each pipe are printed blue in colour on the outside. Each pipe is approx 18 feet 6 inch in length & having diameter of 5.5 inch. On 12.06.2023 while performing evening mobile duty with C/-924 Aswini Pandey of Arsha P.S & C/-1002 Arif Mohammad of SAP 7th BN camp at Arsha P.S Dist-Purulia vide C.C No-1446/23 & GDE No. 514 Dated-12/06/2023 received a direction from O/C, Arsha P.S that one unknown truck is moving suspiciously in Arsha area. As per order of O/C, Arsha P.S I along with force searched the said loaded truck and lastly found the same near Jhunjka Bridge, Hensla G.P under Arsha P.S. At about 22.35 hrs we detained the said truck loaded with the above noted V-DUCPIPEs and the above noted 02 accused persons, but the driver managed to flee away. I interrogated them, and came to know that they along with 07 unknown others were loading the same from unknown place under Arsha P.S and also admitted that the driver & owner of the above noted truck and 07 others involved in this act of stealing the pipes and later selling the same to earn money for wrongful gains. The said pipes are being used for the water pipeline project for delivery of water to villages under Govt. Scheme. It is clear that the above noted truck having Registration No- NL02N/9414 was transporting the stolen pipes. So, I seized the same under proper seizure list in between 22.55 hrs to 23.05 hrs. Dtd. 12/06/2023. I tried to find local uninterested witness but could not find anyone, so the seizure list was signed by Police witnesses. After completion of all process, myself along with force brought the arrested 02 acced persons, seized vehicle to P.S.

I therefore pray before you, to kindly lodge an FIR against 1. Dinesh Sahis (22 yrs) S/O Sudhir Sahis and 2. Bajrangi Munda (21 yrs) S/O Lt. Mangal Munda both of BCCL Colony, Dhowra Goshala OP. under PS- Sindri, Dist- Dhanbad, Jharkhand, 07 unknown and others also against the driver & owner of the truck having Registration No- NL02N/9414 as per law and arrange for its investigation.
