In producing here with two arrested accused persons namely (i) Anil Mahato (60 yrs) S/O Lt. Chinibas Mahato of vill- Dhanara and (ii) Lakhikanta Laya (30yrs) S/O- Lt. Uddhab Laya of vill Hingutanr, both of P.S.-Arsha, Dist-Purulia along with following seized articles.

1) One white colour plastic container with approx 18 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)


I, SI Subal Goswami of Arsha PS do hereby lodge a written complaint against the above noted accused persons to the effect that today i.e 13.06.2023 at about 16.25 hrs. during my Spl. mobile duty at near Mishirdih more, received source information over telephone that the above noted accused persons are selling ID liquor at Dhanara village near rail gate, Puara GP, under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction, I accompanied with (i) C/- 1516 Arnab Sinha of Arsha PS and (ii) C/- 277 Sourav Paramanik of SAP 7th BN Camp at Arsha PS rushed to the spot to work out the information vide Arsha PS C.C. No.1477/21 dtd. 13.06.2023 and GDE No. 563 Dtd. 13.06.2023. After reaching at Dhanara village near rail gate we fixed-up the spot and found that selling of Id Liquor was going on there and seeing the police all customers managed to escape. But we were able to apprehend Anil Mahato who was selling the ID liquor & Lakhikanta Laya who was assisting him in the act. On demand of showing papers they failed to produce any valid documents in support of selling ID liquor. So, I seized all the implicating articles as noted above under a proper seizure list from their exclusive possession in presence of witnesses and properly sealed and labeled approx 500 ml ID liquor was taken out from the above container as sample packed with sealing wax with label. During interrogation they confessed their guilt. So, I arrested them after observing all the formalities under proper arrest memo and following all the guidelines of NHRS & the Apex Court. as they were selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused persons namely i) Anil Mahato (60yrs) S/O Lt. Chinibas Mahato of vill- Dhanara and (ii) Lakhikanta Laya (30yrs) S/O- Lt. Uddhab Laya of vill Hingutanr, both of P.S.-Arsha, Dist-Purulia under proper section of law.


