Sub: To lodge FIR against owner and driver of one tractor without Reg. No. having Engine No. NFNB01448, Chassis No. NFNB01448 along with trolley (sand approx 60 CFT).

Sir,

In producing herewith, 01 (one) tractor without Reg. No. having Engine No. NFNB01448, Chassis No. NFNB01448 along with trolley (sand approx 60 CFT). Today on 15.06.23 at about 05.15 hrs. during night mobile duty vide C.C No. 1491/23 Dtd. 14.06.2023, acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-848 Priyaranjan Senapati of Arsha PS and (ii) C/300 Binoy Mahato of SAP 7th BN camp at Arsha P.S, Dist-Purulia, left for PS area reached at Bhurbhuria Ghat, under Arsha PS at 05.35 hrs, we conducted raid on the Bank of Bandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Bhurbhuria Ghat on the Bank of Bandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Bhurbhuria Ghat, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley at about 05.45 hrs to 06.05 hrs and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
