



Be it mentioned here, that previously the Accused Persons are also entering into the mango garden and theft huge amount of mangoes at night time but on 06.05.2023 the Complainant and witnesses are saw the occurrence, and the Accused persons came into the garden and they also given out threatened that if the Complainant came to the spot then they will murder to the Complainant and his other co-sharers due to the Accused persons have some strong iron rod, knife etc with their hand then Complainant visited to the local police station and lodged complaint but due to Local Police Station did not take any step till 01:00 PM then the Complainant has lodged complaint before S.P. Purulia on
