Myself, Vishal Singh, Father's name -  
Mr. Ramesh Singh (permanent address - 42,  
Kailashnagar, P.O., P.S. Sonari, District - East Singhbhum,  
Jambhedpur - 831011, Jharkhand). Currently I  
reside at, C/O - S.S. Mahanty, 1st block, Manorama  
Colony, P.S. Balarampur, District Purulia - Pin 723143 -  
West Bengal.

I was alone at my current residence on 9th of June 2023  
at around 10 P.M., Debashish Mandal also  
known as Boka Mandal, S/O, Rishikesh Mandal  
of Registry Kaza, Balarampur - 723143, Purulia, W.B.  
started pelting stones at my house,  
I rushed to lock & close the door when he  
grabbed me by my chain & collar and tried  
to strangle me. I narrowly escaped after the  
chain broke and my t-shirt collar ripped apart.  
I successfully locked the front grill but he  
constantly kept abusing and threatening me,  
my family and my house owner. He again  
started pelting stones madly and tried  
to break the lock failing which he  
left the premises and stopped at the  
end of the lane where more men were  
standing and they all left together.

After this I informed my house owner Mr.  
S.S. Mahanty and he very affirmatively said not  
to open the gate or hand over the keys to anyone.

Sir, this all incident was very frightening for  
me, I request you to please look into this  
matter as I highly doubt that he will attract  
more as he threatened me to kill.
