Sub: Complain against (i) Abani Majhi (56), S/O Lt. Naru Majhi & (ii) Indra Majhi (42), S/O Lt. Naru Majhi both of Village- Baharaghutu, PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith accused person namely (i) Abani Majhi (56), S/O Lt. Naru Majhi & (ii) Indra Majhi (42), S/O Lt. Naru Majhi both of Village- Baharaghutu, PS- Bandwan, Dist- Purulia with the seized articles i.e. (i) approx 20 liters illicit distil liquor in 02 white jericans (approx 10 liters each jericans) marked as Exhibit "A" & "B" (ii) Total 02 liters Illicit Distil liquor (01 Litter from Exhibit-"A" & 01 Litter from Exhibit- "B") has been taken out in two separate bottles from mother sample as sample marked as Exhibit "A-1" & "B-1". I beg to submit that on 28/05/2023 at about 19.45 hrs. I received a credible source information while I was engaged in Mobile duty that two persons namely (i) Abani Majhi (56), S/O Lt. Naru Majhi & (ii) Indra Majhi (42), S/O Lt. Naru Majhi both of Village- Baharaghutu, PS- Bandwan, Dist- Purulia is stocking and selling Illicit Distill liquor without any valid license from the back side of dwelling house of Abani Majhi (56), S/O Lt. Naru Majhi at Village- Baharaghutu, PS- Bandwan, Dist- Purulia. Accordingly, myself along with C/1463 Santimoy Ghosh & C/2485 Tirthankar Samanta all of Bandwan P.S., Dist-Purulia vide Bandwan P.S. M.C.C. No. 2464/23 Dtd: 28/06/2023 left for Baharaghutu village to work out the said source information and held raid at the back side of dwelling house of Abani Majhi where the above mentioned accused person stocking and selling Illicit liquor. During search with the help of accompany force, we found that the above noted two persons is stocking Illicit Distill liquor for sell. Being asked, they disclosed that all liquor has been stocked for the purpose of sell. On demand, they failed to produce any valid documents/ License in respect of stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) in between 20.25 hrs to 20.55 hrs after preparing proper seizure list duly signed by the witnesses. Approx 20 liters illicit distil liquor in 02 white jericans (approx 10 liters each jericans) seized marked as Exhibit "A" & "B". 02 (two) liters Illicit Distil liquor (01 Litter from Exhibit-"A" & 01 Litter from Exhibit- "B") has been taken out in two separate bottles from mother sample as sample marked as Exhibit "A-1" & "B-1" and labelled the same. Then, I arrest them at 21.00 hrs. & 21.05 hrs. respectively. After maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court after preparing proper arrest memo as he committed offence U/S- 46A (C) B.E. Act 1909 and supply one copy to them.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused persons namely (i) Abani Majhi (56), S/O Lt. Naru Majhi & (ii) Indra Majhi (42), S/O Lt. Naru Majhi both of Village- Baharaghutu, PS- Bandwan, Dist- Purulia and arrange for its investigation.
