Sir,

In producing here with arrested accused person namely Satveer Kumar Prasad @ Rakesh Singh Sardar (35 Yrs) S/o-Lt. Dinanath Prasad At Adityapur, Near City Classic PO+PS- Adityapur, Dist-Seraikella Kharswan (JKD) A/P C/o- Pardeshi Singh Sardar S/o-Lt. Ranjit Singh Sardar of Hurlung PS-Barabazar, Dist-Purulia and seized articles one Plastic Jerican containing approx 18 (Eighteen) Ltrs of I.D liquor (Cholai), in which 500 ml seized as sample under proper seizure list and Memo of arrest.

I, SI Nimai Ch. Nemo of Barabazar PS do here by lodge this complaint against the above noted persons to the effect that on 01.06.2023 at 15:35 hrs during my day mobile duty received source information that above noted person unauthorizedly keeping & selling I.D liquor (Cholai) at Barabazar Bypass morh near Batllar Ghat under Barabazar PS. I have then verified the credibility of that information and immediately informed to my I.C. As per direction of I.C Barabazar PS myself along with force had been to the spot at 16:05 hrs to work out the information. Seeing the Police party, customers fled away. Somehow we apprehended the seller, On being asked he disclosed his identity as noted above and confessed that he is keeping & selling ID liquors (Cholai) without any valid documents with intent to make his own profit. On searching we found one plastic jarican containing approx 18 (Eighteen) Ltrs. ID Liquor (Cholai) from that place. Accordingly, I seized the same under proper seizure list in between 16.15 hrs to 16.35 hrs duly signed by the said alleged person & witnesses then I took 500 ml from mother contraband as sample and put label on both seized articles. Thereafter, I arrested the accused person namely Satveer Kumar Prasad @ Rakesh Singh Sardar (35 Yrs) S/o-Lt. Dinanath Prasad At Adityapur, Near City Classic PO+PS- Adityapur, Dist-Seraikella Kharswan (JKD) A/P C/o- Pardeshi Singh Sardar S/o-Lt. Ranjit Singh Sardar of Hurlung PS-Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all formalities regarding arrest as per Cr.PC and NHRC guide line, informed him and his relatives regarding the ground of arrest. The arrest was made at 16.35 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered as per law against the above noted accused person namely Satveer Kumar Prasad @ Rakesh Singh Sardar (35 Yrs) S/o-Lt. Dinanath Prasad At Adityapur, Near City Classic PO+PS- Adityapur, Dist-Seraikella Kharswan (JKD) A/P C/o- Pardeshi Singh Sardar S/o-Lt. Ranjit Singh Sardar of Hurlung PS-Barabazar, Dist-Purulia and also arrange for its investigation.
