Sub: Complain against driver and owner of the seized Tractor having Reg. No- WB 55B/ 3481 loaded with approx 75 c.f.t.

Respected Sir,

In producing herewith one Tractor having Reg. No- WB 55B/ 3481 loaded with approx 75 c.f.t sand, seizure lists, seized articles.

I beg to state that on 04.06.2023 myself along with (i) C/1246 Shaktipada Mahato, and (ii) C/ 1250 Jitendra Kr. Dubey, were performing night mobile duty vide Boro PS GDE No. 93 Dtd- 03.06.2023, C.C. No- 1908/2023, Dtd: 03.06.2023, with Govt. vehicle Reg. No. WB 42S/ 4996. Then, I received an information from O/C Boro PS at about 23.55 hrs that a tractor have taken entry at Sindraidih- Bhutadih nadi ghat side under Boro PS to load sand by means of theft from the unauthorized Kumari river bed. Accordingly, as per direction of O/C Boro PS I along with force left for Sindraidih- Bhutadih nadi ghat side to work out the information and after reaching there, started search secretly throughout from Bhutadih side towards Sindraidih side and lastly at 02.05 hrs found that one tractor is remain standing over the Kumari river bed at Sindraidih nadi ghat and illegal sand loading is going on from unauthorized river bed. Accordingly we chassed and reached at the sand loading spot. But, nobody was found there as he/ they fled away and hide himself/ themselves taking the advantage of darkness and found that one tractor bearing Reg. No-WB 55B/ 3481 with attached trolley is remain stand and 3/4 portion of the trolley was already loaded with sand i.e. approx 75 c.f.t sand. We search the entire adjacent area thoroughly for driver and owner of the tractor but failed to trace out anybody. Search was also conducted for any paper / documents relating to vehicle to establish the ownership of the vehicle but failed.

Accordingly I seized the tractor attached with trolley loaded with sand about 75 c.f.t approx bearing Reg. No- WB 55B/ 3481 under proper seizure list which has been duly signed by witness. The seizure was done in between 02.45 hrs to 03.15 hrs on 04.06.2023.

Enquiry reviled that the driver and owner of the said seized Tractor are involve in dealing with extraction of sand which was being procured by means of theft or any fraudulent manner with a view to wrongfully gain.

By this way they violated the regulation of procurement of sand. As such there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. orders. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said tractor.
