Sir,

In producing herewith 01 (One) arrested accused person namely Sukumar Mahato (38) S/O Lt. Nilkanta Mahato of vill- Arahara, PO-Khamar, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 20 (Twenty) plastic bottles containing Country Sprit having 600 ML in each bottles printed as "Dil Khush"(ii) 45 pieces of plastic glass under proper seizure with label.

I ASI. Khageswar Kumar of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (29/06/2023) myself along with (i) C/331 Mansaram Kumar (ii) C/814 Sushabhan Goswami (iii) NVF/778 Samir Mahato and (iv) NVF/1772 Fatik Ch. Kumar all of Jhalda PS was performing anti-crime mobile duty (This refers to Jhalda PS CC No. 1635/23 dated 29/06/2023 and GDE No. 1462 dated 29/06/2023) in PS area. During my mobile duty at about 21:15 hrs I received a credible source information that the above noted accused person selling Liquor illegally from a tea shop situated at vill- Arahara, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at vill- Arahara, PS-Jhalda, Dist-Purulia at about 21:55 hours and held raid in the tea shop of Sukumar Mahato and found that the accused person namely Sukumar Mahato (38) S/O Lt. Nilkanta Mahato of vill- Arahara, PO-Khamar, PS-Jhalda, Dist-Purulia was selling Liquor from his tea shop. Seeing the Police party the buyers fled away. On searched (i) 20 (Twenty) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" (ii) 45 pieces of plastic glass were found in the tea shop of the accused. On demand he failed to produce any license / authority of the said illegal possession of liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labelled, duly signed by the accused person & witnesses in which one piece of plastic bottle Country Sprit having 600 ML printed as "Dil Khush" in a bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing Memo of Arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Sukumar Mahato (38) S/O Lt. Nilkanta Mahato of vill- Arahara, PO-Khamar, PS-Jhalda, Dist-Purulia U/S- 46 (A) (c) of the Bengal Excise Act 1909.
