Sub: Prayer for lodging FIR against aced. Somai Chandra Murmu : (58), s/o- Lt Dhuma Murmu of Vill-  
Udaypur, PS-Joypur Dist-Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Somai Chandra Murmu (58), s/o- Lt Dhuma Murmu of Vill-  
Udaypur, PS-Joypur Dist-Purulia along with seizure – list and seized items as described below, I beg to state  
that on 27.06.23 at about 16:35 hrs during my evening mobile duty (CC No-1151/23, Date-27.06.23 &  
GDE No- 796, Dated -27.06.23), received a source information to the effect that the illicit liquor (Mohulla)  
has been kept at Udaypur village into a house of above noted accused illegally with an object to sale. I  
convey the matter to the OC Baglata IC and as per order of OC Baglata IC. I along with force left for  
Udaypur village to work out the information with the govt. supplied kits box containing white cloth, sealing  
wax, seal, papers, carbons, match box, candles etc. I had been to the house of Somai Chandra Murmu at  
about 16.55 hours. Seeing police van some unknown persons fled away from the house of Somai Chandra  
Murmu. However, I could detain Somai Chandra Murmu and asked about his identity. He revealed his name  
and identify as above and as well as disclosed that he gather the illicit liquor (locally known as Mohulla) int  
his hous for selling and he was the house. However, I along with said accused started a search inside the  
house of Somai Chandra Murmu and found the following item in the said house:

1) One white colour plastic Jariken containing approx 10 (ten) lit. illicit liquor (locally known  
as Mohulla)

I interrogated him about the purpose of the stocking and possessing illicit liquor. He replied it was  
the business of him. On repeated question he told that the persons who fled away were his customers (names  
of those not known to him). However he could not show any documents/papers in support of the possession  
as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List in between 17:05 hrs and  
17.25 hrs & took up its 500ml (approx) into a plastic bottle as sample, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the illicit liquor without any valid  
papers in his shop has prima-facie been made out and for the interest of proper investigation, I arrested the  
above accused at 17.30 hrs accordingly.

Therefore, I pray before you to start a case under section of 46A (c) B.E. Act 1909 against the said  
accused Somai Chandra Murmu (58), s/o- Lt Dhuma Murmu of Vill-Udaypur, PS-Joypur Dist-Purulia.
