

Sir,

In producing herewith one arrested accused person namely Thakurdas Paramanik (46 yrs) S/o-Late Khedan Paramanik of Vill-Palanja PS-Joypur Dist-Purulia under arrest along with seized articles as per seizer list i.e. (1) 10 (Ten) Bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 05 (five) bottle of country spirit each of 180 ml styled as "OFFICER CHOICE" under proper seizure with label.

I, SI Nagendranath Das of Joypur PS hereby lodged a written complaint against the above noted accused person, to the effect that on (26/06/2023) at about 18:35 hrs when myself along with C/-681 Notan Ch Dey, C/-3017 Pradip Mallick were performed Special Mobile duty vide Joypur PS C.C. No-1414 date-26/06/2023, as per my source information I reached at Palanja more in the Shop (Pangumthi) of Thakurdas Paramanik S/o-Late Khedan Paramanik of Vill-Palanja PS-Joypur Dist-Purulia and found that the above noted accused person selling 1) 10 (Ten) Bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 05 (five) bottle of country spirit each of 180 ml styled as "OFFICER CHOICE" in the shop (Pangumthi). On seeing Police persons, he concealed his presence at that shop (Pangumthi), but on searching we able to trace out him and also to found that (1) 10 (Ten) Bottle of country spirit each of 600 mil styled as "DILKHUSH" (2) 05 (five) bottle of country spirit each of 180 ml styled as "OFFICER CHOICE" which was kept conceal in this shop (Pangumthi). On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling country spirit to the local people in Joypur Bazar area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such country sprit. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 19:05 hrs to 19:25 hrs & label duly signed by him and other available witness after taking 01 bottle of DILKUSH as sample out of 10 (ten) bottle of DIL KHUSH each bottle 600 ML & 01 bottle of "OFFICER CHOICE" as sample out of 05 (five) bottle.

During further interrogation he confessed his guilt as such I arrested him today (26/06/2023) at 19:30 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Thakurdas Paramanik (46 yrs) S/o-Late Khedan Paramanik of Vill-Palanja PS-Joypur Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
