Sub - Prayer for lodging FIR

Respected Sir,

In producing herewith arrested accused person Gauranga Bauri (38 Years), S/O-Lt Gulpu Bauri of village - Kalapathar, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 22.06.23 at 20.45 hrs during my evening mobile duty received telephonic information that the above noted accd. selling liquor at Kalapathar village in his house. Accordingly I, ASI Jagu Bauri C/416 Sahadeb Hansda & C/689 Pravash Ch Mahato reached at Kalapathar village in the house of the above noted accused at 21.15 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) One white colour plastic jarikin loaded with approx 09 (Nine) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a bottle as sample with sealed and labeled (2) 05 (Five) no's of white colour plastic glasses. I also seized and labeled all the seized articles under proper seizure list at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 21.55 hrs u/s - 67 Bengal Excise Act 1909 and informing her the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused person Gauranga Bauri (38 Years), S/O- Lt Gulpu Bauri of village – Kalapathar, PS - Kashipur, Dist - Purulia and arrange for its investigation.
