This is to bring your kind notice that I Sri Malay Dhibar S/o - Late Manik Dhibar residing permanently at Shikharipara (Math Para) Bankura PIN- 722101 and presently posted as S.D.L.&L.R.O Manbazar do hereby state that on 03/11/2022 our official E Mail ID (sdllromanbazar@gmail.com) was being tried to be hacked by some unidentified person, resulting in receiving of Notifications from Google for resetting of Password and consequently the Mobile phone of self , Pallabi Goswami (Revenue Officer) & Apurba Mukherjee U.D.C attached to my office got resetted deleting all contacts and personal data thereof .

Also on 06/11/2022 again the official email id was again tried to be hacked using an email id tpandey818@gmail.com as a result a letter have been sent from this end before your end for making and enquiry against the fraudulent persons involved in this matter vide this office Memo No - 557/SDL&LRO/MAN/2022 DT -10/11/2022 .

Again on 28/03/2023 some unidentified person used fraudulent means and created a fake Whatsapp Profile using Mobile No - 8942922004 in my name (MALAY DHIBAR) and used offensive language (LAND MUFIA) and used photograph of my wife and me thereon and sent abusive messages to Sri Arunabha Panda holding Mobile no - 9474615115 and to Sri Sanjit Kumar Sinha Mobile No - 8388935135 using that Whatsapp Id , which defamed my name and reputation of my Land Department under which I am presently working . Not only that the unidentified malicious person also created a fake e-mail ID in my name (malay.dhibar1975@gmail.com) .

Further more it came to my knowledge on 30/05/2023 that the unidentified person created a fake Facebook profile in the name of SUMITRA DEBNATH and gave my official Mobile No- 8768067706 along with the Mobile No - 9932918040 of Sri Apurba Mukherjee, UDC attached to my office thereon and posted a fake post in few Bengali Matrimony Sites which not only hampered our Government activities to a huge extent but also made us mentally & emotionally distorted.

Also on 30/05/2023 an Whatsapp Id bearing Mobile No - 9395860453 sent abusive messages and tried to trap me by giving Financial Offers .

At this point of time finding myself more insecure as the fraudulent unidentified person is constantly using the CYBER SPACE in a wrong manner and is defaming my name and reputation of my family as a result I cannot work properly in my office in a Normal state of mind due to these sort of mischievous activities caused by the unidentified person .

Analysing all these situations I do request you to kindly treat it as FIR and please take strong action as per LAW & CYBER LAW and put the person involved in this matter behind the bars and help me to discharge my Governmental duties in a normal state in a peaceful manner in my office at Sub Divisional Land & Land Reforms Office , Manbazar .


