I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Manik Bauri

P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 06.06.2023 at about 03:20pm I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Manik Bauri, S/O- Madhab Bauri of Village- Kendbedya, P.O- Pedda, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from nearest LTOH line of WBSEDCL.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) One no. 200 watt Incandescent bulb.
- 2) Three nos 60 watt Incandescent bulb each.
- 3) Three nos 40 watt Tubelight each.
- 4) One no. 100 watt Television.
