Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Saddam Hussain (30 years) S/O- Muslim Ansari of Vill-Parbelia Amdanga, PS-Neturia, Dist-Purulia along with one seized Auto having registration No- JH 10BA/3270 loaded with 1 ½ MT (Approx) coal seems to be steam, do hereby lodge a complaint to the effect that on 16.06.23, I, SI Biswajit Banerjee, along with C/159 Dinesh Sardar, C/1319 Soumen Koley and C/174 Tapandas Bauri all are of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 680 Dt. 16.06.2023 & CC No- 1920/23 Dt. 16.06.23. In course of Mobile Duty, at about 22:00 hrs when we reached near Neturia, I received a credible source information to the effect that one Auto having registration No- JH 10BA/3270 loaded with illegal coal coming from Barakar side and will transport the same to Raghunathpur side in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Dishergarh Ghat Naka checking Post and started Naka there. In the mean time at about 22:35 hrs found that the above noted vehicle was coming from Barakar side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the Auto. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he is the registered owner of the Auto and he procured said coal from different illegal coal mines at different area of Barakar side.

So, it is reasonable to believe that the above noted accused driver cum registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, he was trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized Auto having registration No- JH 10BA/3270 loaded with raw coal of 1 ½ MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Saddam Hussain (30 years) S/O- Muslim Ansari of Vill-Parbelia Amdanga, PS-Neturia, Dist-Purulia (Driver cum owner) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him to PS with loaded Auto. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot.

Under the above circumstances a specific case may kindly be started against Saddam Hussain (30 years) S/O- Muslim Ansari of Vill-Parbelia Amdanga, PS-Neturia, Dist-Purulia (Driver cum Owner of the seized vehicle No- JH 10BA/3270) under proper section of law.
