Sub: Complain to start a specific case.

Sir.

In producing herewith one arrested accused person namely Sk. Abdul Majid (28 Years) S/O- Sk. Kudrat of Vill-Murulia, PS-Santuri, Dist-Purulia along with one seized Scooter without registration number (Vespa Blue colour), Engine number and Chassis number not visible and loaded with 500 Kg (Approx) steam coal and approx 10 MT steam coal seized at Pallakhuti near Damodar Riverbank, PS-Neturia, Dist-Purulia in hidden condition in bushy area, I do hereby lodge a complaint to the effect that on 21/22.06.2023 I, ASI Habibul Rahaman Mondal, along with C/1302 Radhagobinda Dhibar, C/159 Dinesh Sardar and C/1228 Babulal Hansda all are of Neturia PS were engaged in PS area night mobile duty vide Neturia PS GDE No- 1128 Dt. 21.06.2023 & CC No- 1976/23 Dt. 21.06.23. In course of PS area night mobile duty at about 01:15 hrs date 22.06.2023 received secret source information of stocking of huge quantity of steam coal at Pallakhuti near Damodar Riverbank, PS-Neturia, Dist-Purulia. Shared the information to my superior's and after receiving your kind order myself along with force left for Pallakhuti to work out the information. Being reached there at 01:45 hrs and after search at the bushy area beside the Damodar Riverbank at Pallakhuti and found huge quantity of steam coal was stocked there in hidden condition and found above noted accused person namely Sk. Abdul Majid (28 Years) S/O- Sk. Kudrat of Vill-Murulia, PS-Santuri, Dist-Purulia was driving one Scooter without number loaded with steam coal at Pallakhuti. He has been asked to produce any valid document in support of stock steam coal and scooter, but he failed to produce any valid documents. Accordingly, I seized Scooter without registration number (Vespa Blue colour), Engine number and Chassis number not visible loaded with steam coal weighing about approx 500 Kg and out of it 03 Kg as sample and another steam coal weighing about approx 10 MT found at Pallakhuti and out of it 05 kg as sample under proper seizure list duly signed by available witnesses. Necessary arrangement has been made for shifting the approx 10 MT seized steam coal and brought the seized scooter with loaded coal at Neturia PS.

Accordingly I arrested him after maintaining arrest rule and on interrogation he disclosed the name of his accomplices as 1) Sk. Jahangir S/O- Lt. Sk. Tayeb , 2) Sk. Irbaj S/O-Sk. Gafur, 3) Sk. Saimuddin all of Vill-Murulia, PS-Santuri, Dist-Purulia and 4) Sanjay Shaw S/O- Lt. Rajkumar Shaw of Parbelia Amdhawrah PS- Neturia, Dist- Purulia & others who were engaged in procuring illegal coal from illegal coal pit and transporting the same in a clandestine manner to another district/state.

So, it is reasonable to believe that the arrested accused (1) Sk. Abdul Majid (28 Years) S/O- Sk. Kudrat of Vill-Murulia, PS-Santuri, Dist-Purulia and above noted his accomplices & others had obtained the said coal either by theft or by any fraudulent means from the illegal coal pits and trying to dispose the same coal in a clandestine manner to another district/state knowing it to be stolen.

Therefore, I pray that a specific case may kindly be registered against accused (1) Sk.. Abdul Majid (28 Years) S/O- Sk. Kudrat 2) Sk. Jahangir S/O- Lt. Sk. Tayeb , 3) Sk. Irbaj S/O-Sk. Gafur, 4) Sk. Saimuddin all are of Vill-Murulia, PS-Santuri, Dist-Purulia and 5) Sanjay Shaw S/O- Lt. Rajkumar Shaw of Parbelia Amdhawrah PS- Neturia, Dist- Purulia & others under proper section of law.
