Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Sujit Kumbhakar (44 years) S/O- Lt. Amulya Ratan Kumbhakar of Vill- Hatinal, PS-Kulti, Dist-Paschim Burdwan along with one seized vehicle having registration No- WB 56H/8650 (Tata Magic) loaded with 2 MT (Approx) coal seems to be steam, do hereby lodge a complaint to the effect that on 28.06.23, I, SI Asim Kumar, along with C/805 Narayan Chandra Dhibar, C/1302 Radhagobinda Dhibar & C/1550 Bharat Ghosh all are of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 1435 Dt. 28.06.2023 & CC No- 2052/23 Dt. 28.06.23. In course of Mobile Duty, at about 19:55 hrs when we reached near Bartoria petrol pump, I received a credible source information to the effect that one vehicle having registration No- WB 56H/8650 (Tata Magic) loaded with illegal coal coming from Dishergarh side and will transport the same to Raghunathpur side in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started Naka there. In the mean time at about 20:05 hrs found that the above noted vehicle was coming from Dishergarh side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry it came to learn that the above noted accused driver along with registered owner of the vehicle have procured said coal from different illegal coal mines at different area of Dishergarh side.

So, it is reasonable to believe that the above noted accused driver along with registered owner of said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized the vehicle having registration No- WB 56H/8650 loaded with raw coal of 2 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Sujit Kumbhakar (42 years) S/O- Lt. Amulya Ratan Kumbhakar of Vill- Hatinal, PS-Kulti, Dist-Paschim Burdwan (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him to PS with loaded vehicle. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot.

Under the above circumstances a specific case may kindly be started against Sujit Kumbhakar (42 years) S/O- Lt. Amulya Ratan Kumbhakar of Vill- Hatinal, PS-Kulti, Dist-Paschim Burdwan (Driver of the seized vehicle No- WB 56H/8650) and registered owner of seized vehicle No- WB 56H/8650 under proper section of law.
