Sub: Complaint against Anadi Mahato.

Sir,

In producing herewith one arrested accd. person namely Anadi Mahato (30yrs) S/O Gurupada Mahato of Vill- Hulka, PS-Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that on 04.06.2023 while I was detailed to perform anticrime night mobile duty in PS area along with force (i) C/699Biswajit Banerjee & (ii) C/994Srikanta Kumbhakar both of Purulia (M) PS vide GDE No 194 Dtd. 04.06.2023, CC No.-2081/23 Dtd-04.06.2023. During my anticrime night mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot at Hulka village and after arriving at the spot and as per your instruction conducted raid in the house of Anadi Mahato under this PS at about 20:15 hrs on (04.06.2023). During the raid 2/3 persons fled away and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he procured and stock the Country spirit for selling illegally from his house. So that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit from his house. Subsequently, I seized **17 (seventeen) sealed bottles DILKHUSH country sprite, each containing 600 ml. In which kept 01 sealed bottles as sample. I seized the same** under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person at 20:45 hrs on (04.06.2023) after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person namely Anadi Mahato (30 yrs) S/O Gurupada Mahato of Vill- Hulka, PS-Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his shop. Under the fact and circumstance kindly take necessary lawful action against Anadi Mahato (30 yrs) S/O Gurupada Mahato of Vill- Hulka, PS-Purulia (M), Dist- Purulia.
