Respected Sir,

In producing herewith the seized vehicles (Tractor) having Registration No- WB55A-4232 attached with Sand loaded Trolley approx 100 cft. with proper Seizure list.

The fact brief is that today (23.06.2023) at 21:05 hrs while I along with force 1) C/2734 Susanta Panda & 2) C/994 Srikanta Kumbhakar both of Purulia (M) PS left the PS for special raid duty in entire our PS Jurisdiction area vide Purulia (M) PS CC No 2280/23 and GDE No 959 Dt. 23.06.2023 in PS area. During my visit in Ranchi Road area , I received a special information from my close source that on 23:45 hrs that a suspicious tractor was loading sand near Katabera Ghat of Kangsabati River. Accordingly I contact with I/C Purulia (M) PS and as per his direction, I along with force proceeded towards Katabera Ghat to work out the tip off. While I along with force arrived at Katabera Ghat and found that 01 (one) tractor was loaded sand at Katabera Ghat of Kangsabati river. I along with force intercepted the vehicle (Tractor) having bearing Registration No- WB55A-4232 loaded with Sand attached with Trolley approx 100 cft with driver. After that I tried to collect more information by questioning this said vehicle driver regarding his and his owner motive, intention and the valid documents paper of this transportation of sand from one place to another .Not only he did not produce any valid documents about this transportation but also he refused to answer all the question that was asked by me at a time. Then I tried to disclosed his identity by questioning him eventually he disclosed his identity by saying that his name was 1. Sergeant Mahato (26yrs approx) S/O- Nabin Mahato of Katabera, Garaphusro P.S.- Purulia(M) ,Dist- Purulia .During my questioning all the things regarding this transportation of sand from one place to another it was reason to believe to me that the owner of the said vehicle as well as driver may be loaded said sand by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that they in cahoots with the owner of the vehicle procured the said sand form Kangsabati River near Katabera Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I without no means arrested the driver of the said tractor namely 1. Sergeant Mahato (26yrs approx) S/O- Nabin Mahato of Katabera, Garaphusro P.S.- Purulia(M) ,Dist- Purulia by maintaining all the rules of proper procedure and guidelines given by court and also seized the (tractor) having bearing Registration No- WB55A-4232 loaded with Sand attached with Trolley approx 100 cft under proper seizure list at about 03:45 hrs to 04:05 hrs in presence of available witnesses duly signed by him. Thereafter, I brought the said seized tractor along with driver of this said vehicle to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner and the driver of the vehicle as they committed offence u/s 379/411/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
