I am the authorized representative working on behalf of the above mentioned Bajaj Allianz General Insurance Company hereinafter called as 'Company'. The company is into the field of General Insurance and we also cater Motor Insurance policies.

On 17 Aug 2022 we have received a notice from Honourable Alipore MACT Court that a motor accident claim was registered against our insured company for vehicle number OR22A4601. On perusal of the petition copy it is found that a policy number OG-19-9906-1806-00044590 is mentioned in the petition for the above vehicle. After our detailed scrutiny it is found that no such policy was issued to the alleged Pick Up Van bearing registration number OR22A4601 covering from 19-Oct-20 to 18-Oct-21 to Vivekanand Majhi S/o Haren Chandra Majhi resident at Vill. Satra PS. Arsha, Purulia - 723154. This policy numbered OG-19-9906-1806-00044590 mentioned in petition was dispensed to Jai Bhagwan at outset of our company for Two Wheeler bearing registration no. DL4SBF0460.
