Respected Sir,

In producing herewith the seized vehicles (Tractor) having (i) Chassis No. 05557367R1 (Mahindra B275 D1) (ii) Chassis No. 05557267B1 (Mahindra B275 D1) attached with Sand loaded Trolley (No numbers) approx 100 cft. with proper Seizure list.

The fact brief is that today (03.06.2023) at 13:45 hrs while I along with force 1) C/994 Srikanta Kumbhakar & 2) C/531 Shib Shankar Mahanty both of Purulia (M) PS left the PS for Spl. Patrolling duty vide Purulia (M) PS CC No 2070/23 and GDE No 139 Dt. 03.06.2023 in PS area. During my Spl. Patrolling duty, I received a tip off at 13:55 hrs that suspicious tractors were loading sand near Bhul Ghat of Kansai River. Accordingly I contact with I/C Purulia (M) PS and as per his direction, I along with force proceeded towards Bhul Ghat to work out the tip off. While I along with force arrived at Dimdiha more on Aimundih Pitch road (NH-18) and found that 02 (Two) tractors were loaded sand at Bhul Ghat of Kansai river. I along with force intercepted the vehicles (Tractor) having (i) Chassis No. 05557367R1 (ii) Chassis No. 05557267B1 attached with Trolley (No numbers) loaded with Sand approx 100 Cft. and I found the vehicles as well as goods as identical as I received prior information. So I, seized the (tractors) bearing (i) Chassis No. 05557367R1 (ii) Chassis No. 05557267B1 attached with Sand loaded Trolley (No numbers) approx 100 cft. (approx) under proper seizure list at about 14.20.hrs to 14.55 hrs in presence of available witnesses duly signed by them. The owners/driver of the said vehicle as well as drivers loaded said sand by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that they in cahoots with the owners/drivers of the vehicle procured the said sand form Kansai River near Bhul Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. Then I arrested one owners/driver namely Bikash Mahato (30 yrs) S/o Baburam Mahato of Sindri (Chasmore), PS-Purulia (M), Dist-Purulia at 14.40 hrs. (Chassis No. 05557367R1). Thereafter, I brought the said seized tractors to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner/driver of the vehicles as they committed offence u/s 379/411/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
