I SUSMITA PATRA(SINGHA MAHAPATRA), D/o Sankar Singha Mahapatra, W/o Karali Pada Patra, Presently residing at Nazarul Palli, P.O. Dulmi Nadiha, P.S-Tamna PS, Dist. Purulia, Pin 723102 do hereby submits as follows:-

That I got married with one Karali Pada Patra on dated 04/03/2022 and our marriage was an arrange marriage organized at Rajguru Palace ,Dulmi Nadiha, Purulia.

That according to the demand of my aforesaid husband and in laws, my parents paid a sum of Rs. 15,00,000/- as dowry demand out of which Rs 1,00,000/- and Rs. 2,00,000/- paid on dated 24/01/2022 to S.B.I. account no-39499180451(IFSC-SBIN0002008) from Indian Bank(IFSC-IDIB000P063) account no 50298126317 and 20551950171 respectively. Rs 5,000 paid on dated 14/01/2022, and Rs. 4,95,000/-paid to Banshi Dhar Patra i.e. my father in law to his SBI bank account No. 39499180451(IFSC-SBIN0002008) from my account No. 50298126317(IFSC-IDIB000P063), and again Rs. 4,00,000/- paid on dated 28/02/2022 to my aforesaid husband namely Karali Pada Patra to his bank account No. 104620012088(IFSC-IBKL063JS95) and again on dated 07/02/2022, Rs. 1,00,000/- Paid from my sister's bank account namely Dipali Singha Mahapatra vide account No. 22419649628(IFSC-IDIB000J601) to my father in law's P.N.B. bank account 0706010224406(IFSC-PUNB0070620). and on dated 05/01/22 cash of Rs. 2,00,000/- to my husband, as per their demand.

And as per the demand of my husband and in-laws my parents also given one divan, one Almira and other furnitures amounting are 1,50,000 /- and also given gold and silver ornaments Rs. 10,00,000/- on the date of my marriage, and very next date i.e. on 05/03/2022 my husband bring me at my matrimonial home and I also started to live with my husband and in-laws under one roof in comess.

That from the very inception of my marriage my husband and in-laws are not satisfied with the provided dowry and they always asked me to bring more dowry from my parents and on refusal my husband and in laws tortured me both physically and mentally.

That on dated 10/5/22 my husband and father in law asked me to bring Rs. 20,00,000/- as post marital dowry to develop their residential building and when I refuse to do so they assaulted me with fist and blows and locked me in a room and also cut the electricity connection and did not provide any fooding for next two days.

That again on dated 02/07/2022 my husband asked me that I should told my father to provide Rs. 20,00,000/- as post marital dowry but when I stated my husband that he is self sufficient to develop his residential property as he is an employee of state of Jharkhand and employed at Nahachibera Primary School, Patamda P.S Bhadubera, Dist.- East Singhbhum as Asst. Teacher and he has handsome salary which is not less than Rs.70000/- and on the other hand my father is unable to fulfill any further demand as they have already expend all their savings on my marriage. To fulfill their dowry demand my husband became furious and started to abuse me in filthy language and assault me with fist and blows and beat me with a bamboo stick by which I got several internal and external injuries.

That being a docile lady I tolerate all this torture with a hope that one day my husband and in law should realize their guilt, but all in vain my husband and in laws did not provide me proper fooding even they locked me in a room after cutting the electricity connection for 2 to 3 days on several occasion and my husband assaulted me physically in most of the night on regular basis by which I have passed my days with a great mental agony and in trauma.

That lastly on dated 28/03/2023 the situation come to its zenith and my husband and in laws came to me and stated that either I should bring Rs. 20,00,000/- from my parents otherwise they will not allow me to stay at my matrimonial home but when I am showing my parents in ability to fulfill any further dowry demand they became furious and started to beat me mercilessly, my husband and my father in law also attempt to cause death by entangling Saree over my respiratory track with the utterance and my sister in law kicked on my belly although they are well known that I am already got conceived but with the intention to murder me and my womb baby.

They tried their label best but somehow I can save myself and inform to my father ,accordingly my father came to my matrimonial home and rescue me, then I am forcefully driven out of my matrimonial home by my husband and in-Laws and after snaching all the streedhan property and belongings and they also keep all my academic and identity proof papers in their custody, my aged father seeing my situation and health condition bring me to D. M. Govt. Medical College and Hospital Purulia and with the advise of the Doctor my father admitted me to the hospital and after treatment I was discharged from the hospital but till now I am under treatment.

That after this incident on and from 28/03/2023 I am staying at my parental house at the above mentioned address and several attempts has been made by myself and my parents for reconciliation but all are in-vain and my husband and in laws straight forward denied to accept me without getting the dowry amount of Rs. 20,00,000/-

That due to business with my treatment and for the purpose of reconciliation I could not filed the complaint in proper time and I pray to condone the delay.

That in the above mention fact and circumstance it is therefore requested before you and your good office to take the necessary legal action against my husband and in laws.

I sign this written complain after reading and understanding the contents with my own language.
