Sir,

I, Mr. Bijay Kumar Choubey, son of Late Chandi Prasad Choubey, aged about 53 years, resident of Purulia municipality ward No. 12 Rup chand Pandit Lane, Post Namopara, P.S Purulia (T) and District Purulia 723103, would like to ventilate my utmost grievance that on 01/06/2023 (Thursday) at around 2.30 p.m. when my cousin brother namely Sunil Kumar Choubey and his son namely Aditya Vardhan Choubey were in four-wheeler bearing vehicle number WB 56H 3448, standing in front of their work shop 'Samsung Care' & the above named accused dash his scooty (number not known) with the said four-wheeler. My brother requested to leave the matter and allow him to go, but he began to utter filthy languages aiming towards my brother and his son & also my family members. They requested him why are you abusing instead of giving side but he stated that he will do what he likes. In the mean while he started slapping my cousin brother continuously and my brother's son who was sitting in the driving seat got down and tried to stop the person but he rather started hitting my brother's son with fist & blows & lastly with his boots he continuously hit my brother's son on the right leg knee. He also threatened them that if they dare to lodge any diary against him, they will face serious consequences. He also snatched the gold chains of my brother and his son. Due to the grievous hurt My brother son had serious internal injury in his right leg knee. He was in pain and started using pain killer but the pain was continuous till 03/06/2023 morning and he was unable to put his leg on the floor. Immediately I called my family doctor and he suggested to move as soon as possible to the higher centre because it's the internal injury and needs to be functioned immediately. So as per my family doctor's direction we on 03/06/2023 afternoon moved by road to Bhubaneswar AMRI and on 05/06/23 the doctor operated his right leg knee and on 07/06/23 he was discharged with complete bed rest. We stayed there in my relative house and lastly after consulting doctor on 15/06/2023 we came back to purulia. Still my brother's son is unable to walk and it will take several months to recover completely. In the mean while my brother also told me that Rupees ten thousand was also there in the tshirt pocket which the above said person snatched. The delay in filing the complaint is due to the ongoing treatment of my brother's son.

Hence, I would request you to take action against the heinous offence committed by the above said person.
