## Purulia Town P.S

since 18 Jan 2007.

1. Mrs Mousumi Sen is daughter of Shri Manindra Karmakar and Mrs smitti karmakar resident of Bhatbandh BELGUMA PURULIA ,WEST BENGAL (Mob No 9382547630 / 9002690225) and my sister and she is legally married to Mr Subir Sen s/o late Sisir Sen Asnabad, Chattala Ward No 5 KODERMA JHUMRI TALAIYA JHARKHAND 825409

2. Few months after her marriage my sister MOUSUMI has been facing mental. harassment,torture,verbal abuse, in-human behaviour and activities of cruelty by Mr Subir and his family members to include his mother Mrs. Anjana Sen and sisters namely Swapna Sen and Chandana Sen (now both are married) numerous times my parents got Mousumi (their daughter) back to their native Purulia due to which W B. Out of the wedlock Mr Subir sen and Mrs Mousumi Sen my sister, one male child was born on 19 Dec.2007.

- 3. On numerous occasions a compromise was done between family members and also in church with a assurance from Mr Subir (and his family's side) as a legally wedded husband he will take care of my sister, however over the years the same has not fructified on ground and in real day to day life thus providing no relief to my sister's mental agony till now.
- 4. In the last few years since marriage, mental harassment, verbal abuse, torture and activities of cruel and in-human nature continued against my sister. Mr Subir sen denied appropriate medical treatment to my sister Mrs Mousumi Sen whenever required and on numerous occasions my father Mr Manindra karmakar and my mother Smt Smriti karmakar and myself physically took her for various treatment to vellore, Delhi and Ranchi in-spite my parents being a senior citizens and myself engaged in various operational duties on border areas.
- 5.Mr Subir Sen kept my sister Mrs Mousumi Sen isolated on first floor of his parental house at koderma in poor living conditions while he himself stayed in ground floor with his parents in better living conditions which is in-human in nature.
- 6. Mr Subir Sen denied conjugal rights to my sister Mrs. Mousumi Sen in-spite being legally married to him and there is no physical relationship between him and my sister since last 12 years. He hardly interacts with my sister on the first floor of his parental house at koderma. My sister is compelled to compromise her happy married life, her health, her mental peace or reverting back to her parents in-spite of acts of cruelty by her husband Mr Subir Sen on fear of separation from her son Mst Arnab sen as she is emotionally attached to him.
- 7. Mr Subir Sen and his family members kept the son Mst Arnab Sen is kept away from my sister (Mrs Mousumi Sen) and occasionally coerced Mst Arnab which resulted in complete isolation, loneliness and painful mental agony of my sister. Presently the Mst Arnab Sen is grown up and occasionally ill treats my sister on instigation and even manhandled my sister which my sister informed my father.
- 8. Mr Subir Sen have been emotionally blackmailing my sister Mrs Mousumi Sen inbehest of child's care, child's education and child's future and compelled her to return from her parental home while she was in custody of my parents post the marital discord and subsequently my sister was accompanied by Mr Subir with the assurance that she will be taken care and all rights to her will be restored however problems of harassment, ill treatment, denial of conjugal rights, isolation still persists.
- 9. On 26 Jan 2019 my sister Mrs Mousumi Sen in ill health under mental agony, with no support from Mr Subir as husband, attempted to commit suicide and thereafter it was learnt by me that she was extremely ill with number of health ailments.
- 10. In first week of Mar 2019 my sister was Mrs Mousumi Sen legally wedded wife of Mr Subir sen was rescued by me (Colonel Manabendra Karmakar) from his parental house

at koderma initially to Ranchi with multiple illness which indicated deprivation of food, medicines and proper care at his end. Thereafter proper medical treatment and diet was administered to her by me and in my parent's custody at Ranchi and Purulia. During the treatment myself and my parents learnt that due to continuous and prolonged isolation, loneliness, mental harassment, torture, denial of conjugal rights amounting to various forms of domestic violence and acts of cruelty by Mr Subir and his family members along with multiple illness (which were unattended at his place) Mrs Mousumi Sen has detoriated her mental health.

- 11. Post homely treatment of my sister Mrs. Mousumi Sen in my parents custody of other health ailments for considerable period, I (when I again came back on leave) took my sister for treatment of her mental depression at Central Institute of Psychiatry (CIP)kanke.Ranchi on 01 Jun 2019. Consequently, my sisters treatment was carried out in custody of my parents at Purulia in form of medication, psychological and behaviour therapy, family support therapy for 3-4 months.
- 12. Post treatment of my sister Mrs Mousumi Sen which was continuing for about four months (when she recovered form depression and all types of illness)at my parent's place Mr Subir Sen again emotionally blackmailed my sister on behest of child's requirement and his personnel interest of doing of household chores to include cooking at his parental home, he took her back at his parental house at koderma in Sep 2019 with the assurance to my parents and all family members that he and his family members will take care of my sister Mrs Mousumi Sen and will not harass or abuse and will live a happy conjugal life hereafter.
- 13. Mr Subir Sen again isolated my sister Mrs Mousumi Sen ,denied her conjugal rights and matrimonial space, remained separated as husband on ground floor of his parental house, hardly interacted with her didn't provide her medicare which resultantly lead to detoriation of mental health which now is life threatening. The same was learnt by me when my parents and me when we interacted on phone with my sister Mrs. Mousumi Sen on 21 Aug 21.
- 14. In first week of May 2023 my father was verbally abused by MR subir sen and he asked my father to take my sister Mrs Mousumi sen and Mst Arnab sen (her son) away from his parental home at koderma bact to PURULIA. On 04 /05 May 23 my father was again threatened by Mr Subir Sen and he threatendly stated that that he will get my father killed. When my father interacted with my sister she informed that Mr Subir Sen (HUSBAND) has beaten her on provocation by Mrs Anjana Sen and Mst Arnab Sen (Son) also reacted against my sister & subsequently she went to the police station to lodge a complaint.
- 15.On 14 Jun 23 I along with my father and mother rescued my sister who was in poor mental state from parental home of Mr Subir at koderma Jharkhand and took her to CIP Ranchi for medical treatment. She is presently in custody of my parents at our parental home in Bhatbandh Purulia under medication.
- 16. On 18 Jun 23 Mr Subir sen again created ruckers at my native place Purulia Bhatbandh and continued his threatening to me and my family members.
- 17. Mr Subir sen's atrocities are grave towards my sister and is life threatening which includes physical and verbal abuse, in-human acts of cruelty while he is also an alcohol addict.

18. In view of the above it is requested that appropriate action to be initiated.
