Respected Sir,

In producing herewith the driver namely Raja Bauri (25 yrs) S/O Swapan Bauri of Vill- Dabar Balarampur, PS- Purulia (M), Dist- Purulia & along with seized vehicle (Tractor) Bearing Reg. No. WB55B-4318, Chassis No-MBNSFAVEBLNH00432, Engine No- NLH5FAE0089 attached with loaded Sand Trolley and with Seizure list, Memo of Arrest and Inspection Memo in respect of the above noted person before you.

The fact brief is that today (21.06.2023) at 18:45 hrs while I along with force 1) C/1335 Nirmal Mahato & 2) C/420 Sk Chand both of Purulia (T) PS left the PS for RT mobile duty vide Purulia (T) PS CC No 1941/2023 and GDE No 1345 Dt. 21.06.2022 in PS area. During my day mobile duty, I received a tip off at 19:15 hrs that a suspicious tractor loaded with sand was coming from Kansai river side towards Purulia Town. Subsequently, I along with force proceeded towards Katin Para near Kali Mandir to work out information. While I along with force arrived near Katin Para near Kali Mandir on Pitch Road under Purulia (T) PS and found that 01 (one) tractor was coming towards Purulia Town along Old Manbazar Road. I along with force intercepted the vehicle (Tractor) bearing No. WB55B-4318 attached with sand loaded trolley without any number plate at 19:25 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of said vehicle disclosed his name as noted above. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor as well as carrying sand. I repeatedly asked the driver to produce the valid paper but he stated in coherent statement in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling/transporting the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Kansai River under Tamna PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Bearing No WB55B-4318 attached with Trolley loaded with Sand without any number plate under proper seizure list in between 19:45 hrs to 20:15 hrs. in presence of available witnesses duly signed by them and also arrested the driver Raja Bauri (25 yrs) S/O Swapan Bauri of Vill- Dabar Balarampur, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Purulia (T) PS compound.

Under the above facts and circumstances I beg to pray kindly take lawful action against the owner of the tractor bearing No. WB55B-4318 and the arrested driver of the tractor namely Raja Bauri (25 yrs) S/O Swapan Bauri of Vill- Dabar Balarampur, PS- Purulia (M), Dist- Purulia of the vehicle and others if any as they committed offence u/s 379/411/414/120B of the IPC & 21 (4) of Mines and Minerals (R&D) Act-1957.
