I Sri Ramniranjan Agrawal s/o Late Biswanath Agrawal a resident of Chunabati, Reny Road, P.O. , PS + Dist- Purulia would like to inform you that yesterday i.e., on 21/06/2023 at about 11 A.M. I left my house at lock condition for my business place at S.N.Sarkar Road, Purulia, After I come back to home after closing my shop at 8.30 pm I found the lock of my two rooms were broken and two gates of another two rooms in broken condition. When such incident took place my wife was not present there because she went to her parental home on dated 19/06/2023 around 2.00 P.M. at Nilkuthi Danga Purulia for three days. The whole house was in scattered condition and some of old and ancestral precious articles made of gold and silver which were gifted to us during our wedding ceremony, And articles were purchased/received by us in different occasion, some house hold articles were stolen away.

Under the circumstances it is clear that some unknown miscreants after breaking the lock and doors of the rooms entered into the rooms and opened the almirah by using keys and stolen away the articles mentioned above. I am unable to submit purchases bill but we shall identified those articles if those are produced before us.

In this regard you are requested to take necessary steps by which the wrong doers can be punished in accordance with law.
