In producing herewith 04 (four) arrested accused persons namely (1) Mustak Ansary (38Yrs.Approx.) S/O Mamtaz Ansary of Gopinathpur, PS- Raghunathpur, Dist- Purulia (2) Imtaz Ansary (33 Yrs. Approx.) S/O Junaboli Ansary of Uparjari PS- Arsha, Dist- Purulia (3) Ziaul Mustafa @ Ansary (25 Yrs. Approx.) S/O Mahammad Rahamadtulla of Digudih Para, PS- Purulia Town, Dist- Purulia (4) Aktar Ansary (34 Yrs. Approx) S/O Akbar Ansary of Gopinathpur, PS- Adra, Dist- Purulia along with following seized articles (i) One dark ash coloured RENAULT KWID Car without number plate bearing Engine No. E136021, Chassis No. MEEBBA001H2462236 (ii) One Country made improvised fire arms made of iron having butt, body and barrel, butt with barrel length 10.1" (inch), barrel length 7" inch (iii) One live cartridge ammunition with a length of 03 inch upon which KF, 70, 7 is engraved on percussion cap (iv) One iron rod with a length of 3'9" (v) One battle axe made with iron with a length of 09", handle made with bamboo wood with a length of 14" (vi) One 2/3rd filled glass bottle of McDowell's No-01 Celebration Rum, Two unsealed bottled of 'Dilkhush' (vii) One unsealed & one sealed Sujata No.1 Biri & one 'SHIP' match box (viii) One white coloured & red- green bordered scarf.

That today (16.06.23) at 20:55 hrs I received secret information from a source that a gang of criminals comprising of 10/12 heads under the leadership of Mustak Ansary (38Yrs.Approx.) S/O Mamtaz Ansary of Gopinathpur, PS- Raghunathpur, Dist- Purulia with vehicle being armed and well equipped with deadly weapons etc beside pitch road of Orang Para near Gopal More. They were roaming about with a view to commit dacoity at above noted place.

Accordingly I informed the matter to I/C Purulia (T) PS over phone and as per instruction I along with C/420- Sk. Chand, C/1256 Anadi Dhibar, C/3192 Tarun Sahoo, C/2394 Kushal Mondal, C/2041 Uttam Man and C/2653 Nirmal Mahata vide Purulia (T) PS C.C. No. 1885/23 dated- 16.06.2023 and GDE No- 1009 left to work out the information by a Govt. vehicle. At 21.35 hrs we reached at above noted place keeping the vehicle from a distance of about 50 yards & we cordoned them. But when we reached nearer they all started to flee away from getting down the vehicle. After a hot chase we could able to apprehend above noted 04 persons & after disclosing our identity we detained them. On a thorough interrogation they disclosed their identity as noted above and they gave incoherent statement in different times which is very suspicious. They also stated that one Sikandar Ansary (19 yrs) S/o- Salim Ansary of Gopinathpur PS- Adra Dis- Purulia was with them but he fled away. On being searched I seized the vehicle: dark ash coloured RENAULT KWID Car without number plate bearing Engine No. E136021, Chassis No. MEEBBA001H2462236 which was used by the above noted persons as stated by them. Thereafter I searched the said vehicle in presence of them as well as witnesses, found following articles were present inside the vehicle which were kept by them, seized under proper seizure list & labelled. (ii) One Country made improvised fire arms made of iron having butt, body and barrel, butt with barrel length 10.1" (inch), barrel length 7" inch (iii) One live cartridge ammunition with a length of 03 inch upon which OK, 05, 7Z is engraved on

One iron rod with a length of 3'9" (v) One battle axe made with iron with a length of 09", handle made with bamboo wood with a length of 14" (vi) One 2/3rd filled glass bottle of McDowell's No-01 Celebration Rum, Two unsealed bottles of 'Dilkhush' (vii) One unsealed & one sealed Sujata No.1 Biri & one 'SHIP' match box (viii) One white coloured & red-green bordered scarf. So it is crystal clear that they were assembled in that area to commit dacoity and thus liable for punishment U/S 399/402 IPC & 25/27/35 Arms Act. The above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons and available witnesses. They could not produce any document in respect of improvised fire arms and ammunition. The entire process of seizure & arrest has been completed from 22:15 hrs. to 22:55 hrs. It is crystal clear that they were assembled at that place to commit dacoity within Purulia Town P.S area and also they were aware of the existing of the arms & the ammunition inside the vehicle and after committing the crime they would flee away by vehicle.

On return to PS, I lodge complainant against (1) Mustak Ansary (38Yrs.Approx.) S/O Mamtaz Ansary of Gopinathpur, PS- Raghunathpur, Dist- Purulia (2) Imtaz Ansary (33 Yrs. Approx.) S/O Junaboli Ansary of Uparjari PS- Arsha, Dist- Purulia (3) Ziaul Mustafa Ansary (25 Yrs. Approx.) S/O Mahammad Rahamadtulla of Digudih Para, PS- Purulia Town, Dist- Purulia (4) Aktar Ansary (34 Yrs. Approx) S/O Akbar Ansary of Gopinathpur, PS- Adra, Dist- Purulia (5) Sikandar Ansary S/o- Salim Ansary of Gopinathpur PS- Adra Dis- Purulia and others for starting a case U/S 399/402 IPC & 25/27/35 Arms Act and also for arranging its investigation.
