I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(b) & 1(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 12/06/2023 at 16.45 Hrs. I Sri Subhajit Pratihar, AE & SM Purulia CCC WBSEDCL along with Biswanath Barul (AE S&LP attached to Purulia Regional Office WBSEDCL), Promod Ranjan Barman (Special officer attached to Purulia Regional Office WBSEDCL), Chinmoy Maity (JE Purulia CCC), Anurag Pandey (OE Purulia CCC), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Zafrul Hasan, Son of Noorul Hasan, resident of J.K.College Road, Idga Mahalla, Purulia(T) Thana, Dist Purulia by serving one entry notice duly signed by the consumer representative.

During the time of inspection at the premises 2 nos of electricity meter were found having serial no GE01741630 (Consumer id 202315035, Consumer Name- Zafrul Hasan) & FB007084 (Consumer ID -242026885, Consumer Name- Noorul Hasan).

It was observed that consumer Zafrul Hasan has made unauthorized use of electricity under section 135 1(b) & 1(d) by inserting foreign material in meter serial no GE01741630, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 4 nos (60 watt each), Light 5 nos (9 watt each), Pump 1 nos 746 watt, Tv 1 nos 80 watt, AC 2 nos 2250 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter GE01741630. Prepared seizure list duly signed by the accused.

The inspection team left the premises at about 17.15 Hrs on 12th Jun 2023.

The accused committed theft of electricity U/S 135 1(b) & 1(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
