In producing herewith the accused person namely Md. Mannan, S/O- Lt. Md. Sheru of Kasaidanga, Ward No- 08, PS- Purulia (T), Dist- Purulia along with seized articles i.e. (1) One black colour old Money Purse (2) One Aadhaar Card of Md. Mannan having Aadhaar No- 259557592402 (3) 02 (two) pieces of Two Thousand Rupee (2000/-) currency notes (All notes seems to be fake) (4) 02 piece of five hundred Rupee (500/-) currency note and (All notes seems to be fake) under proper seizure list.

I, SI Jayanta Maji of Purulia Town PS arrest one FIR named accused Md. Mannan S/O- Lt. Md. Sheru of Kasaidanga, Ward No- 08, PS- Purulia (T), Dist- Purulia in c/w Purulia (T) PS Case No- 91/2023 dated 05.06.2023, U/S- 341/323/326/308/427/506 IPC. FIR named accused person Sk. Mannan taken into 03 days PC with a view to recover offending weapon. On interrogation he confess that he assist me to recover the offending weapon and he also stated that very recent he start a business of transform the fake currency as genuine in market due to his injured leg and he cannot move or walk randomly. That is why his an old friend Sk. Babu @ Sk Sonu, S/O- Ali Hossain, Of- Katin Para, PS- Purulia (T), Dist. Purulia A/P Vill-Hijuli, PS – Hura, Dist. -Purulia who also notorious criminal provided him Rs-2000/- and 500/- rupee counterfeit currency notes of Rs- 16000/- (sixteen thousand) to dispose the same to another who will transform the fake currency as genuine. Md. Mannan distribute those counterfeit currency notes in the local market and other places via his various close friends namely (1) Sumit Barman @ Bangali S/O- Rajesh Barman , Of- Old Police Line More, Near Amru Sweet Shop, Ward No- 14, PS- Purulia (T), Dist- Purulia (2) Sk. Suvan @ Sk. Pintu @ Wanted S/O Sk. Akthar of Idga Mohalla, new Femina Road near Kabarsthan, Ward No-09, PS- Purulia (T), Dist- Purulia (3) Sarfaraj Querashi @ Hairan , S/O- Aktar Querashi of Digudih Para, near Pond, Ward No-08, P.S-Purulia (T), Dist- Purulia. He also confesses during interrogation that he already given Rs. 4000/- to one Sumit Barman @ Bangali, Rs. 4000/- to Sk. Suvan @ Sk. Pintu @ Wanted and another Rs. 3000/- to Sarfaraj Querashi @ Hairan for transform the fake currency as genuine. Accused also stated that Sk. Babu @ Sk Sonu collected the counterfeit currency notes from Sk. Monu, S/O- Lt Sk. Kabad of Vill- Hussaindih, P.S-Jhalda, Dist- Purulia. I diarized the whole matter in GDE vide Purulia Town PS GDE No 492, Dated-08.06.23

There after myself along with ASI Sk Abdul Jamshed, C/915 Parimal Mukherjee, C/11 Kajal Mukherjee, C/ 2366 Anupam Das with PC accused Md. Mannan left PS vide CC No- 1802/23, Dated-08.06.23 to recover offending weapon in c/w Purulia Town PS case no 91/2023 dated 05.06.2023, U/S- 341/323/326/308/427/506 IPC and fake currency which is PC accused disclosed during interrogation. Myself and force with PC accused arrived at the house of Md.

Mannan and started search after maintain all searching formalities. I seized the sharp cutting Knife offending weapon as shown produced and identified by the PC accused Md. Mannan which he used during the commission of the crime and also he handed over one black colour small Money Purse where I found some cash and Aadhaar card of Md. Mannan on it and I seized the same i.e. (1) One black colour old Money Purse (2) One Aadhaar Card of Md. Mannan having Aadhaar No-259557592402 (3) 02 (two) pieces of Two Thousand Rupee (2000/-) currency notes (All notes assumed to be fake) (4) 02 piece of five hundred Rupee (500/-) currency note and (All notes assumed to be fake) under proper seizure list duly sign by the witnesses. PC accused also stated that very recent his one close friend Sk. Babu @ Sk Sonu collect those counterfeit currency notes from Sk. Monu S/O- Lt Sk. Kabad of Vill- Hussaindih, P.S-Jhalda, Dist- Purulia. I seized the offending weapon in c/w Purulia Town PS case no 91/2023 dated 05.06.2023, U/S- 341/323/326/308/427/506 IPC. Copy of the seizure list were given to the accused person acknowledge in the seizure list. After seizure all the seized article properly sealed and level in presence of the witnesses and persons seized level were made in between 17:15 hrs to 17:55 hrs.

Under this circumstances, I request you to initiate a case against (1) Md. Mannan, S/O- Lt. Md. Sheru of Kasaidanga, Ward No- 08, PS- Purulia (T), Dist- Purulia (2) Sumit Barman @ Bangali S/O- Rajesh Barman , Of- Old Police Line More, Near Amru Sweet Shop, Ward No- 14, PS- Purulia (T), Dist- Purulia (3) Sk. Suvan @ Sk. Pintu @ Wanted , S/O Sk. Akthar of Idga Mohalla, new Femina Road near Kabarsthan, Ward No-09, PS- Purulia (T), Dist- Purulia (4) Sarfaraj Querashi @ Hairan , S/O- Aktar Querashi of Digudih Para, near Pond, Ward No-08, P.S-Purulia (T), Dist- Purulia (5) Sk. Babu @ Sk Sonu, S/O- Ali Hossain, Of- Katin Para, PS- Purulia (T), Dist. Purulia A/P Vill-Hijuli , PS – Hura, Dist. -Purulia (6) Sk. Monu, S/O- Lt Sk. Kabad of Vill- Hussaindih, P.S-Jhalda, Dist- Purulia and others U/S 489A/489B/489C/120B IPC who are damaging the economical balance of the market and destroying our society by using this fake currency. The racket should detect and arrest the rest accused persons immediately.
