I, Mihir Ranjan Pattanayak, S/o Late M. Pattanayak AADHAR NO. 457331573294, working in M/s. Shyam Steel Works Private Limited, JSK-II, Village- Lachhmanpur, P.O.- Ramkanali, P.S.- Raghunathpur, Dist- Purulia, Pin-723133, (hereinafter, referred to as "Our Company") as Sr. Manager (Corp. Affairs) would like to bring to your kind attention about the incident that has occurred within the factory premises of our company, which are describing as below :


On 02.06.2023, at about 20.20 hrs our security personnel namely Mr. Manbodh Singh S/o Sriram Singh, Mr. Santo Bauri S/o Late Madhu Bauri and Mr. Palash Sengupta S/o Late Mihir Sengupta, caught two persons in a two-wheeler (Regn. No.: JH10AR-6946) with two plastic containers of 30 Liters, full of diesel (total 60 Liters) near security gate no. 2. During the enquiry, the said persons, i.e., Mr. Sarjed Sekh Sarahad and Mr. Sekh Rajij pushed our security personnel forcefully and in this process, fled after leaving the said two-wheeler. After contacting the contractor M/s. Ansari Contractor and the owner of the Hyva (Dumper) Mr. Shekh Jannat, he brought both the accused to our office on the very next day i.e., 03.06.2023. The accused have accepted their crime with a written statement and also informed us that they sold this diesel to Mr. Kalimuddin, owner of Kalu Tyre repairing Shop near Lachhmanpur more. It is further brought to your kind notice that such acts have been committed regularly since the last few days. A copy of concerned driver & his helper's statement is attached for your reference.

I therefore request your good self to lodge this complaint as FIR against the above accused persons and all persons involved in this racket. Also request you to investigate the offence properly and punish them as per law.
