



- 3) That IIFL Samasta finance Limited is a micro finance institution committed to working towards women's economic empowerment. Since its inception in March 2008, IIFL Samasta is being provided innovative and affordable financial products to women from un banked sections in society in both rural and semi urban areas. Today as the organization caters to 18 states including the West Bengal across India, IIFL Samasta with its wide array of responsible financial products and services acts as a catalyst for sustainable and inclusive economic growth.
